**CEREMONIAL ITEMS - Spotlight on Hampton Heroes**

Mayor Tuck introduced Robin McCormick, the City's Communications Strategist, who participated by Zoom and shared that tonight's Spotlight would be a rebroadcast of the Hampton Heroes virtual event which took place on January 18, 2021.

Ms. McCormick greeted the Council and stated that the memorial recognizes Dr. King and Hampton citizens who have had an impact on Hampton through a commitment to peace, justice and progress. This year the City honored people who were trailblazers in history dating back to the founding of this Country and the Civil Rights Movement and after.

The video featured an introduction from the Mayor followed by the Pledge of Allegiance. Youth Pastor of C3 in Hampton, Pastor Chris Cox, gave the invocation. Mayor Tuck continued with an introduction on the first group of Hampton Heroes as community leaders.

The community leaders honored were as follows: Lilly Mae Jones, William Alfred Smith, Lillian Epps Johnson, Jacob Heffelfinger, Dr. Chester Lee Brown, and Anderson W. Clary Jr.

The trailblazers in history honored were as follows: Ruppert L. Sargent, George Wythe, William H. Trusty, William Tucker, Andrew W.E. Bassette, Harriet Tubman, Rosa Parks, and Alice Bacon.

The trailblazers in public service honored were as follows: Linda D. Curtis and B.J. Roberts.

At the end of the video, footage from the Martin Luther King Jr. and Hampton Heroes Memorial Plaza was presented.

Following the broadcast, Mayor Tuck thanked the staff and his fellow members of City Council for their work on this program. and then adjourned the meeting at 6:42 p.m.
