To whom it may concern,

This note is to express the ownership interest in George Restaurant LLC to modify our current zoning status from Restaurant 2 (R2) to Restaurant 3(R3). We are not seeking to expand the restaurant sq footage 1832 sq ft at this time to allow for smoking, that may come in a separate request when applicable.

We are pleased to report the success of our venue with R2 status has met and at times exceeded our predictions in terms of customer positive satisfaction reviews. We are becoming a designation spot for people from all around the 7 cities. We fell that getting the restaurant 3 designation would help us achieve more success.

Currently we are not allowed to use our entire stage which is 210 sq ft. As per the floor plan we have tables placed on the stage so that the entire stage cannot be used for performances. We are seeking approval to be designated as restaurant 3 so that we can:

- 1- To use our full stage of 210 sq ft
- 2- To allow stage to be used for dancing/dance shows during special events.
- 3- To extend our hours of operations, primarily on the weekends.

Allowing us to use more of the stage would help us expand the types of entertainment we are able to provide. For example, we have been in discussion with the Hampton City Youth Council to use Saturday afternoons, from 1pm to 4pm as “Youth Showcase” time. We are in touch with colleges, high schools and community organizations that could help us bring our vision to life of providing a space where our youth can feel safe and showcase their talents beyond doing a “TIK TOK” video. Being parents and grandparents, we feel providing a space where kids can interact and socialize in person instead are hiding behind computer and phone screens will make have a positive impact in our communities.

We want to expose youth to forms of music like Classic & Contemporary Jazz, RnB, and other performing art forms like Spoken Word, Ballet, Latin, African or Tap. We could allow youth choirs to perform during holiday seasons and not have them squeezed into a small space. This would be a great back drop to the toy and food drives we plan to do.

We have also been in touch with a few church organizations to set up a “Sunday Showcase or Sunday’s best” for various choirs and praise dancers to perform on stage as which may sometimes require full use of the stage.

Allowing dancing on our stage during special events would give our patrons a full experience when celebrating milestones. For example, we had a family celebrate their parents 60 years of

marriage. They wanted the couple and family to dance on the stage to the same song they had danced to 60 yrs ago. We were not able to grant their request.

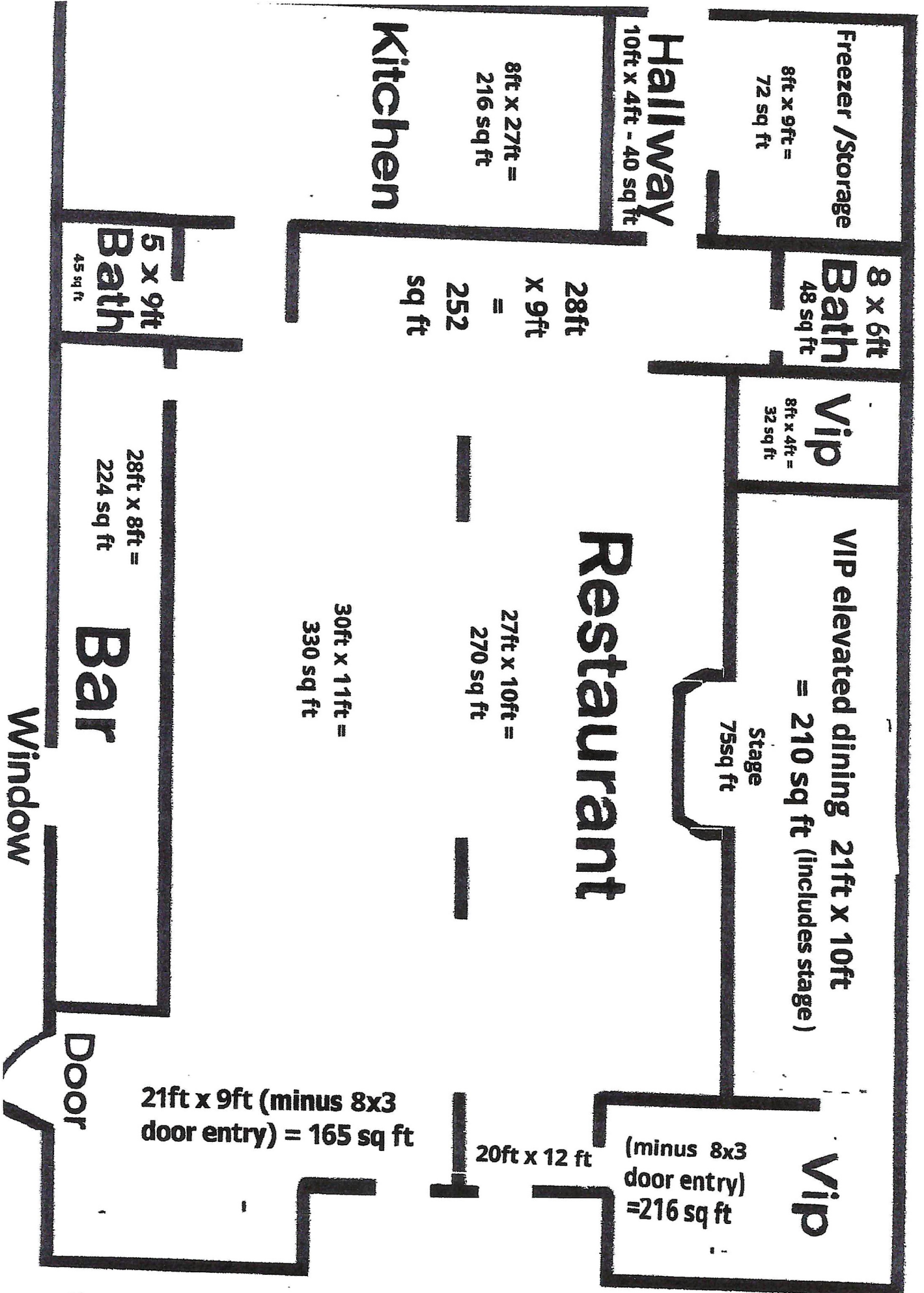
We look forward to being a space that the young and old of the Hampton Community can enjoy. We have the backing of the community as evidence by the number of people who signed our support petition.
