

# **River Street Park Steering Committee**

## ***Summary Recommendations – November 9, 2021***

The existing River Street Park, for community planning purposes, can be divided into three key areas: (a) the Southern Entrance Plaza, (b) the area Under the Freeway, and (c) the Northside Waterfront. Each of these park areas has unique assets and amenities that were installed with intention during the original design in 2006. The following is a brief summary of the three principal areas of the park:

- **Southern Entrance Plaza:**

This area includes a large plaza that provides a gathering space for activities or small events. The entryway includes decorative brick pavers, ornamental black fencing, signage, trees, landscaping and benches.

- **Under the Freeway (VDOT Right of Way):**

Some of the most unique features of the park are located Under the Freeway and/or adjacent to the VDOT right-of-way. These include a history walk timeline of significant Hampton events, an intricate pattern of decorative pavers and plants, true-north pavement compasses, a waterfront walkway with commanding views of the Hampton River, benches, landscaping, gravel walking trails, as well as some on street parking.

- **Northside Waterfront (VDOT Property):**

Located north of the freeway on the VDOT property is a Kayak launch/pier, landscaping, and water views.

A River Street Park Steering Committee was comprised of residents from Pasture Point, Downtown Hampton stakeholders, and the Neighborhood Commissioner for the area. The Steering Committee members were asked to guide a process to determine community priorities. They were also instructed that their valuable input would be used to inform, but not necessarily determine, future decisions. The Committee held discussions at neighborhood meetings, conversed with neighbors, and conducted an online survey to capture community input. Over the course of 6 meetings, the Steering Committee developed the following preferences regarding the various elements in the park based on the input from their community.

Ultimately, the Committee expressed a desire to see the park restored to its original condition as quickly and completely as possible. The Committee desired that any structural or element changes to the park be considered through minor redesign work to move elements within the whole area of the park if at all possible. The following guidance is provided for each of the three main areas of the park.

### **1. Southern Entrance Plaza:**

- 1.1 The City's portion of the plaza should be closed during construction.
- 1.2 Pavers/furniture should be placed in storage to avoid potential damage.
- 1.3 The plaza pattern should be redesigned for post construction installation based on the way the new park would function and the remaining footprint of the VDOT ROW with the potential to incorporate some of the elements from under the freeway.
- 1.4 Decorative fencing, landscaping and trees, and the entryway signage located on City property should remain as much as possible during construction and replaced after construction.

### **2. Under the Freeway:**

- 2.1 The compasses & history walk will likely need to be removed for construction and should be replaced if possible,
  - If relocation is necessary, the area where the history walk/compasses once were should incorporate a low-maintenance paver/pathway solution.
  - If necessary, these elements should be incorporated into the redesigned plaza, or
  - Relocate to another location within the neighborhood, such as the linear park/trail.

### ***Summary Recommendations – November 9, 2021***

- 2.2 Preserve and repair the pedestrian bulkhead pathway under the bridges and remove/replace benches. Consider allowing and installing enhanced overlook elements (i.e. pier, lighting, railing enhancements) along the bulkhead pathway.
- 2.3 Allow a crushed stone path to loop back between the pylons to either connect to any potential surplus VDOT property or back out to River Street on the northside of the interstate.
- 2.4 Ensure use of low maintenance landscaping and materials (i.e. pavers, crushed stone) throughout.
- 2.5 Preserve open design as much as possible, limit the use of chain-link fencing only where required.
- 2.6 Replace the decorative fencing and use such fencing along both sides of River Street under the freeway.
- 2.7 Remove the parking spaces under the freeway.

### **3. Northside Waterfront**

- 3.1 Depending on the ultimate outcome of the VDOT project's project impact on the northside property, and the City's opportunity to acquire or secure access to any surplus property acquired as part of the project, then the recommendation is to explore reinstalling the boat launch, along with replacement parking.
- 3.2 If the boat launch cannot be located near the existing park, then relocation to another site in the neighborhood should be explored first. Storage for the elements should be provided until a new, suitable location is determined, up to and including time for any necessary property use or acquisition to take place.
- 3.3 If relocating the boat launch within the neighborhood is not feasible, then the funds intended to relocate the pier should be reinvested into a new or existing pier on the Hampton River (e.g. Mill Point) to improve accessibility.
