



AFFIDAVIT

**Certifying Individual Written Notice Mailing to Property Owners Subject to
Rezoning 24-0187**

I, Bonnie N. Brown, Director of the Community Development Department of the City of Hampton, Virginia (the “City”) and Secretary of the Hampton Planning Commission, hereby certify that the Hampton Planning Commission, through the Community Development Department, provided individual written notice in compliance with VA Code § 15.2-2204(B) to the property owners whose parcels are subject to the zoning map amendment known as Rezoning 24-0187, as identified in Exhibit A. Rezoning 24-0187 creates the Coliseum Central 4 Zone of the Short-Term Rental Overlay (O-STR) District. I further attest and certify that the following are true:

1. On April 1, 2024, the GIS Manager of the City compiled from the City Assessor’s current real estate tax assessment records the names and mailing addresses of the property owners whose parcels are subject to Rezoning 24-0187;
2. Output Services Group, Inc. (“OSG”) was contracted by the City to print and mail postcards to the property owners whose parcels are subject to Rezoning 24-0187;
3. On April 23, 2024, the City sent OSG the postcard proof as well as the names and mailing addresses of the property owners pulled from the City Assessor’s current real estate tax assessment records;
4. Between April 23, 2024 and May 2, 2024, OSG created and printed postcards matching the proof provided by the City and addressed to the property owners per the mailing list provided by the City; and
5. On May 2, 2024, OSG mailed the postcards to all property owners on the mailing list provided by the City via first class mail.

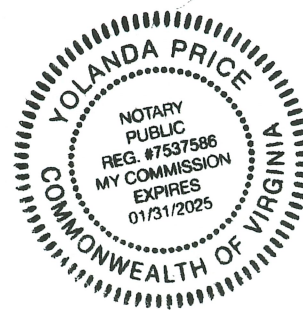
