




## Effect of Federal Policy Changes on Local Government

Delays and possibly alters funding received through grants	Causes other direct and indirect impacts to budget
Imposes new mandates that may require local implementation	Changes regulations that affect local services

### **Potential Impacts to Grant Funding**

- Currently, a federal funding freeze cannot be legally implemented due to rescission of the OMB memo and legal injunctions that have been entered
- Federal review to identify and make recommendations to eliminate federal support of DEIA, environmental justice and similar programs or actions is ongoing.



Began tracking issuance of Presidential Directives, related documents and legal challenges

Inventoried current grant awards to determine:

- source of funding
- amount of award and status
- amount expended to date



Began expediting reimbursement requests for expenditures already incurred



Began review of grant associated contracts to ensure termination clauses are appropriate in the event that funding were to be delayed or canceled

Began performing ongoing assessment of level of risk based on current guidance/directives

Sought written assurance from granting agencies that work on grants can continue and city has assurance of reimbursement

## **City Actions**

Identified staff positions that are grant funded:

- In process of assessing
  - Funding source(s) for the position
  - Level of assessed risk to that funding source

Continuing to reassess existing directives that have impact to public buildings, public schools and DEIA programs and positions and their impact related to federal funding

 Continuing to track new directives and any projected impact to city operations

### **Fiscal Impact**

#### As of January 28, 2025:

**Total Grant Budget -** \$121,773,658.04 **Grant Expenditures -** \$17,302,013.54 **Unreimbursed Expenditures -** \$2,037,677.22 **Purchase Order Encumbrance Balance -** \$4,619,562.34

**Federally Funded Grant Positions:** 

81 positions Salaries Total: \$4,300,902 Salaries and Fringes Total: \$6,582,933

**Outside Agencies Receive Federal Grant Funds Totaling -** \$81,142,822

Grant periods range from 2018-2027 and some until work/project is completed.

## Other Factors that Could Cause Local Impacts

- Actions of current administration:
  - Reduction in federal workforce either through resignations or terminations
  - Reduction in federal programs
  - Impacts to tax benefits from Tax Code Changes
- Impacts to Federal facilities in our city and surrounding area
- Impacts to residents who live and work in our city who are federal employees
- What cascading affect will occur if federal pass through funds are cut to the state

May have short term and long term impacts of a magnitude which we cannot quantify until we have specifics of what is getting cut or changed

## Summary

- Elimination of DEIA and environmental justice funding will have:
  - direct impact to multiple grant awards
  - will be affected by multiple legal challenges filed
- Staff continues to monitor the possible fiscal impact; current guidance to departments is to expedite reimbursement of unreimbursed expenditures

## Summary

- City is determining policy direction on spending of current grants before incurring more costs that need to be submitted for reimbursement
- Staff is working to determine which programs are essential and should be prioritized regardless of the status of federal funding and are working to identify alternative funding sources

## Summary

- Staff is also working to track memoranda that will be forthcoming from various federal offices to provide the plans, reports and actions called for in the presidential directives
- We are also tracking legal actions that are being filed that will impact timelines or implementation
