MAYOR'S COMMENTS

Mayor Tuck read and presented a proclamation to the Rotary Club of Hampton, Virginia on the occasion of their 100th anniversary. He announced May 30, 2021, as Rotary Club of Hampton, Virginia Day and asked members to stand. President Dr. Coleman thanked the Council for recognizing the Rotary Club, acknowledged contributions and activities throughout the City, and mentioned their dedicated membership.

PRESENTATIONS, PROCLAMATIONS, AWARDS

PUBLIC HEARINGS

A Hampton city resident and representative for the applicant, Allison Schmidt, spoke on behalf the American Legion Use Permit.

"Hi. My name is Allison Schmidt. I'm a Hampton City resident in the area of Phoebus. I'm sorry about the misunderstanding, but I did sign up downstairs. I'm a little bit nervous, so please excuse me. Thank you Mr. Brown, I appreciate that. We are a veteran's organization. I don't know exactly when our particular group was started but it was around World War II. The first building that I know of is where the McDonald's stands in Phoebus now. We sold that and we moved to Mellon Street which was a beautiful building but this day and time you only have so many active members and when you have 28 active members and a huge building it just doesn't work. So we sold it to Charlotte's and they've got wonderful food there I'm understanding. But we do a lot for the community. I understand this is in PH1 but directly across the street and I think you have pictures of it is Old Point Bank which really doesn't fit the historical Phoebus. If you look to the side, and I've got the pictures here but you can see the back of all the historical buildings and the a-frames and the sheds and everything. Here again, this building is a good transitional building, I feel like, with the flags and the flowers and everything it's going to be pretty coming off of the interstate because right now all you can see is trucks and sheds and steps and a-frames and flat roofs and everything. Across the street there are the brand new apartments that are three stories. If you look down directly, Lancer's is on one side. I don't have to tell you'll about Lancer's. Then next beside us is an empty parking lot and then we have an empty lot then we have native development then we have a house then we have a gas station and then we have Hardee's. So it's really not in the historic Phoebus area. I do want to say the American Legion does a lot. We have roots over there at the Hampton VA (Veterans Administration) now. Many of our members actually run the clothing room for veterans. We do the toiletry room for veterans. We have members that actually run the Poppy Program at the Hampton VA which is the only VA in the state of Virginia

that the actual Veterans make poppies. We support Jane Bryant School...”

Mayor Tuck asked Ms. Schmidt to repeat the name of the program. Ms. Schmidt stated that the veterans make the “Memorial Day Poppies”. She continued her presentation.

“We support Jane Bryant, which is a Title I school. We work with the people over there. In the past we have helped with the Hampton History Museum, the Police Memorial, and the lovely clock that is on your visitor book and I believe it’s on some of these face masks, was donated by our post. So I hope you’ll consider us. I really appreciate it. We work hard. If there’s any concern about parking or whatever, Phoebus closes down on Monday. We can change our meeting to Monday, but when you only got 28 active members and most of them are husband and wife or buddies and friends it’s not that many vehicles. We hope to grow. We hope to get some young blood in there because we do know we need to support our veterans. But here again, I appreciate it and thank you for putting up with me. Any questions?”

No questions were provided. Mayor Tuck closed the Public Hearing.

City Manager, Mary Bunting, introduced Senior Planner, Allison Jackura, to present the American Legion Use Permit.

During the slideshow presentation, Ms. Jackura discussed the application for the permit describing it as the first permit of its kind that allows deviations from the development standards rather than focusing on a particular use. She stated the presentation will focus on the form and development proposed.

Ms. Jackura displayed an illustration of the zoning location of the property and reviewed public policy for Hampton, LU-CD Policy 15 for maintaining street network

while meeting the needs of pedestrians, LU-CD Policy 31 to promote the efficient use of land, and ED Policy 10 to foster successful redevelopment of properties within the City. She summarized the public policy from the Phoebus Master Plan discussing new construction to honor historical building styles, reinforce Main Street character, window installations, avoiding blank walls, compose buildings, and using brick materials. She continued with deviations requested including building width, façade zone, and building side setback. The fenestration and primary door visibility were altered to comply during the review process and now meet zoning ordinance.

Ms. Jackura described illustrations of the building from the front elevation facing S. Mallory Street and from the right side elevation facing Lancer Street. She described the site concept plan outlining the two properties being combined into one. She discussed how an analysis was reviewed based on the alignment of the Community Plan and Phoebus Master Plan. The applicant met with Phoebus Partnership during the application process and notified Phoebus Partnership of the completed design.

Ms. Jackura stated that the staff recommended three conditions for Item #21-0137: permit applies to this property; site design vacates property line, compliance with elevations, and compliance with site concept plan; and nullification if the building isn't built.

Ms. Jackura stated that staff and the Planning Commission recommend approval of the use permit application with three conditions.

Mayor Tuck opened the floor for questions and comments from Council.

Councilman Bowman asked questions about solar components and LEED certifications for the building.

Ms. Jackura informed Council the information was provided during the Phoebus Partnership meeting but not included in the Site Plan design.

Councilman Brown complimented on the building structure and stated, "It was good to know that the Partnership for a New Phoebus was in total agreement with it. It fits with the integrity of the community and I think it's a great project."

PUBLIC COMMENT

Ms. Glass read the protocol for public comment.

Mayor Tuck apologized for not asking the representatives from the American Legion to stand.

Tammy Ishmael was the only person signed up to speak for public comment.

“Good evening. This is my first time in a council meeting and I just wanted to take note that this was important to me about the budget. I did have a chance to review the budget and I wanted to give some positive feedback because it directly impacts my family and my community. I was happy that we raised money or raised the salaries for our City employees as well as our teachers because that’s directly going to impact our students. The fact that we’re going through a pandemic, I was happy to see that Hampton is still continuing to grow and still continue to do great things despite the fact that we’re going through a pandemic. So, I just wanted to acknowledge you all and say thank you for the hard work you’ve done on the budget and I fully support it. Thank you.”

GENERAL ITEMS

Mayor Tuck asked Mrs. Bunting to provide comments on the budget ordinances presented for final vote.

Mrs. Bunting's comment is as follows:

“Thank you Mr. Mayor. In tonight’s meeting the City Council will take a final vote on the budget. This vote has been preceded by two public hearings on the budget that were hosted on April 28th and May 5th. At its last meeting, Council conducted an initial vote on the City’s FY2022 budget and appropriation ordinances that require two readings. Those were ordinances that by City code cannot be passed on the same day as their introduction. These ordinances include those appropriating money exceeding the sum of \$5M dollars and those imposing taxes. The budget ordinances that require only one reading for adoption were also on last week’s agenda but only for Public Hearing. For voting tonight, each budget tax and fee ordinance will be voted on separately. Please note that the budget ordinances, even when finally approved, will not be effective until July 1, 2021, or January 1, 2022, in the case of personal property taxes. I do also want to note that earlier this afternoon in afternoon session we discussed three minor amendments to the budget. Two of these relate to organizational dues for organizations the City belongs to where the dues were slightly higher. Those notices came in after we proposed a recommended budget. In the first case Virginia First Cities, which is an organization that represents the core urban localities in the State, raised its dues \$138 and then the

Hampton Roads Planning District Commission, which is a regional organization all of our localities participate in raised its dues \$3,136. And even though those are minor amounts it was discussed that Council would like to have that reflected in the minutes so that those are proper in the budget document for someone who might look historically. The third thing was that the Housing Authority, Hampton Redevelopment and Housing Authority requested an additional \$25,000 to support the ability to raise the rate that they pay for extra duty police officers to do community engagement and patrolling in their areas. Federal funds cannot be used for these purposes. The rate that they pay has not changed in many, many years and thus was not competitive with what the private sector was paying and they wanted to address the rate to be more competitive so that they're not at a disadvantage when hiring extra duty police officers. Again that would be \$25,000. So in the motions tonight, staff has given you the language necessary to amend the budget. There's no change in revenues but we will be covering the total of \$28,274 with a decrease in grant matching funds and then those would support the \$25,000 for the Hampton Redevelopment and Housing Authority outside agency contribution, and additional \$3136 for the Hampton Roads Planning District Commission, and an additional \$138 for Virginia First Cities."

Mayor Tuck apologized to Communication Strategist, Robin McCormick, for a statement made earlier that may be misconstrued.

Ms. Glass read the motions required for second and final votes.

REPORTS BY CITY MANAGER, CITY COUNCIL, STAFF, COMMITTEES

In reference to the American Recovery Plan, Ms. Bunting stated that The City of Hampton will receive \$48.7 million dollars to invest in various efforts and programs including infrastructure (water, sewer, broadband, storm water, and coastal resiliency activities), residents, businesses, City facilities, programs, and services to assist the City to recover from the pandemic. She noted that states and territories cannot lower the tax rates as a result of receiving these funds but is not sure if localities are included. Mayor Tuck also stated that COVID was challenging but he believes this budget reflects the Council's priorities. He also shared that earlier today a potential project coming to Hampton indicated their desire was influenced by Hampton's Academies.
