Project Description: Mass shootings are occurring more often throughout the nation with more than 646 events documented in 2022 (Gun Violence Archive). During the past few years, our region has experienced multiple mass shootings requiring extensive multidisciplinary collaboration and garnering national attention with the most recent event occurring November 2022. In a continuing effort to prepare to combat and respond to these possible event(s), the cities of Hampton, Newport News, Poguoson, Williamsburg and the counties of York and James City are requesting funds to support Phase II of our Family Reunification Center(s)/Family Assistance Center(s) (FRC/FAC) planning, training and exercise for our employees and communities. This investment project will allow us to develop a series of training events and exercises within each jurisdiction and/or regionally on the Peninsula. Continuing to plan for regional operational coordination is a regional priority. Lessons learned from each training and exercise will be used to update the 2022 Peninsula Regional FAC Basic Plan and Annexes. Independent lone actors, homegrown/domestic violent extremists and/or foreign terrorists are living in our communities. Recent events and lessons learned from domestic violent extremism incidents exemplify that the capability to efficiently and effectively open and operate an FRC/FAC is imperative for crisis and consequence management. The Region V Measure (RVM) emphasizes the importance of the FRC/FAC in Capability 19.6: Active Family Reunification/FA Center within 6-8 hours.

In 2022 they met on a regular basis in order to develop the 2022 Peninsula Regional FAC Basic Plan and Annexes. Having a dedicated part-time planning coordinator to assist in scheduling trainings and exercises with all the localities and stakeholders is vital to the success of the program. This planning coordinator will also update the 2022 Peninsula Regional FAC Basic Plan and Annexes as areas of improvement are identified through the trainings and exercises. Law Enforcement will play a key role in the planning, training and exercising so some of the funding will be allocated to improving their capabilities to support a local/regional FRC/FAC.

Training

In 2022 the Peninsula localities completed the draft 2022 Peninsula Regional FAC Basic Plan and Annexes. The next step in ensuring that the employees and community are trained in the various aspects of the plan and how to implement and operationalize it. Only a limited group of regional partners who worked on the plan and annexes are currently aware of the specifics on implementing the plan should the need arise. It was identified that the planning group needed to provide a series of trainings both specific to individual jurisdictions and then regional trainings on the plan. Law Enforcement will have focused, targeted training along with participating with others in the community training. Progressive trainings will be built related to each learning concept culminating with a series



of final exercises. The cost of instructors, overtime to complete training, and backfill if needed will be determined by the planning group.

Exercise

As the series of trainings are held, a complementary series of exercises will be scheduled and conducted. We will follow the HSEEP model with workshops, tabletop exercises, functional and full-scale exercises. These exercises will enable employees and stakeholders to put their training into practice in order to test the plan. Areas of improvement are inevitably identified through exercises and the 2022 Peninsula Regional FAC Basic Plan and Annexes can be updated to reflect necessary improvements. Law Enforcement personnel will be active participants in the exercises. The cost of instructors/facilitators/contractors, overtime to complete exercises, and backfill if needed will be determined by the planning group. These exercises will allow the region to strengthen working partnerships prior to an event caused by independent lone actors, homegrown/domestic violent extremists and/or foreign terrorists.

would have to then seek future funding to continue the planning, training and exercise to ensure they are able to fully prepare their staff and community to open an FRC/FAC during times of emergencies.
