VACATION AGREEMENT

(Portion of Sanitary Sewer Easement at 19 Ducette Drive)

THIS VACATION AGREEMENT (this "Agreement"), made this _____ day of May, 2017, by and between the <u>CITY OF HAMPTON, VIRGINIA</u>, a municipal corporation of the Commonwealth of Virginia located at 22 Lincoln Street, Hampton, Virginia 23669 (the "City"), and <u>TERRY L. PLYMOUTH</u>, owner of the property located at 19 Ducette Drive, Hampton, Virginia 23666 (the "Owner").

WHEREAS, the City holds a sanitary sewer easement over the rear portion of Owner's property at 19 Ducette Drive (LRSN 13001038), a portion of which comprises 376 square feet (0.0086 acre), more or less, located in the City of Hampton and more particularly described as:

Parker, Parker Surveying, Inc., 6858 Michael Lane, Hayes, Virginia 23072, which is attached hereto as Exhibit "A" for reference and made a part of this legal description (the "Vacation Area");

WHEREAS, Owner owns the residential property located at 19 Ducette Drive (LRSN 13001038);

WHEREAS, the City holds a sanitary sewer over the rear portion of Owner's property comprising 2,214 square feet (0.0508 acre), more or less;

WHEREAS, Owner requests the vacation of an area comprising 376 square feet (0.0086 acre), more or less (the "Vacation Area"), to construct a two-car detached garage;

WHEREAS, pursuant to § 34-120 of the City Code, the City waives the purchase price of the Vacation Area because the easement was conveyed to the City without charge via the subdivision plat including Owner's property that was recorded in May 2004; and

WHEREAS, the City, acting by and through its City Council, is of the opinion that the Vacation Area is not now and will not be needed for public interest.

NOW, **THEREFORE**, in accordance with Chapter 34, Article V of the Hampton City Code, the City of Hampton, Virginia, acting by and through its City Council at its duly held meeting on the 24th day of May, 2017, does by these presents release, quit-claim, and vacate unto Owner the following described property interest, to-wit:

FEET[,] AREA OF EASEMENT BEING VACATED" as shown on that certain plat entitled: "VACATION PLAT OF A PORTION OF SANITARY SEWER EASEMENT BELONGING TO THE CITY OF HAMPTON," said plat bearing a date of April 5, 2017, and signed April 25, 2017 by Randall R. Parker, Parker Surveying, Inc., 6858 Michael Lane, Hayes, Virginia 23072, which is attached hereto as Exhibit "A" for reference and made a part of this legal description.
