## Purpose

# Purchasing and Procurement Oversight Committee (PPOC)

Reviews purchasing and contractual procedures and practices of all agencies and departments of the city; recommends improvements that result in greater fairness, simplicity, cost effectiveness and broader participation; and monitor results.

# Small Woman-Owned and Minority-Owned Businesses (SWaM)

As part of the mission of the Department of Economic Development, SWaM efforts focus on enhancing growth opportunities for Virginia's small businesses to prosper through increased revenue and job creation, thereby raising the standard of living for all Virginians.





#### **PPOC**

- 11-member Committee appointed by City Council for four-year terms
- Quarterly meetings
- Staffed by the Department of Economic Development




# Minority Business Programs

- FY2026 budget of \$75,587
- "Provide support for the growth of SWaM (minority and womanowned) businesses in the City of Hampton. This is accomplished by cultivating and developing the program and implementing policies that facilitate increased used by the City and Hampton City Schools of minority and woman-owned businesses in procuring goods and services. Develop and promote training events to assist small, minority and woman-owned businesses with growth and stability."

#### Local Options for SWaM Participation in the Code of Virginia

<u>Virginia Code § 2.2-4310.B</u> provides that localities shall establish written procurement programs to facilitate participation of small, women owned (WBE), minority owned (MBE), service disabled veteran owned business, & [disabled] employment services organizations. Any such program shall comply with the requirements of § 15.2-965.1.A.

<u>Virginia Code § 15.2-965.1.A</u> states that any locality may enact an ordinance providing that whenever there exists (i) a rational basis for small business enhancement, or (ii) a persuasive analysis (i.e. disparity study) that documents a statistically significant disparity between the availability and utilization of women-owned and minority-owned businesses, the chief executive of the local governing entity shall be authorized and encouraged to require implementation of appropriate enhancement and remedial measures consistent with prevailing law.



#### Local Options for SWaM Participation in the Code of Virginia

<u>Virginia Code § 15.2-965.2</u> allows any locality to enact an ordinance to enhance micro business participation in its purchasing. For this purpose, a micro business is defined as a small, women owned, or minority owned business with no more than 25 employees.

Virginia Code § 2.2-4303.G While not directly pertaining to SWAM, the Virginia Procurement Act does allow for expanded opportunities for purchasing without competitive or sealed bidding (i.e. small purchases). By increasing these limits in City Code, more purchases would be subjected to our current quote requirements for woman and minority owned businesses.

<u>Virginia Code § 2.2-4317.D</u> allows for localities to have a prequalification ordinance for construction contracts requiring a minority participation plan. The minority participation plan may be used as a basis for the locality to deny prequalification. Any such participation plan must comply with applicable requirements of federal and state law. Hampton currently does have a prequalification ordinance but it does not speak to minority participation in construction.



#### Best Practices for Race & Gender Neutral Programs (Partial Listing)

#### **Practice**

#### Small Business & Disadvantaged Business Certification

Certifications in Virginia are performed at the state level.

#### **Small Business Sheltered Market Programs**

Virginia Code Virginia Code § 2.2-4310.B allows for localities to establish small business programs. Virginia Code Section § 15.2-965.1.A requires a rational basis for these programs, a lower standard than the statistical analysis (disparity study) required for programs that are race and gender conscious. Virginia Code § 15.2-965.2 specifically allows localities to enact an ordinance require small purchases be made from microbusinesses of no more than 25 employees.

#### **Sheltered Bidding Processes**

For example, the City of Virginia Beach currently utilizes a sheltered bidding process for small businesses. All construction contracts under \$500K and contracts for goods and non-professional services under 100K are limited to SWaM certified small businesses (this is waived when the City cannot find three ready, willing, and able SWaM businesses to bid on the work).

#### **Small Business Development Centers**

The City of Hampton actively partners with the Virginia Small Business Development Network.



#### Recommendations

- Sunset the PPOC and establish a SWaM Business Committee
  - Primary mission of advocacy and outreach to SWaM businesses
  - Inform programming and business development efforts to support the attraction and growth of SWaM businesses in Hampton
  - 7-member body
    - A minimum of five SWaM certified business owners
  - Quarterly meeting schedule
  - Annual report to City Council and the City Manager
  - Staffed by the Department of Economic Development
- Establish a working group of internal and external stakeholders to review and recommend changes to the City's SWaM business related procurement policies and practices Staffed by the Procurement Office
- Realign existing staffing resources between the Department of Economic Development and the Procurement Office to achieve the City's desired outcomes for SWaM businesses and procurement practices with separate reporting to City Council and the City Manager
