



#### 3.5% increased 20+%




## **Property Tax Rate**

- Propose to keep the real estate tax rate at \$1.24
- American Rescue Plan will benefit Hampton by up to \$51 million
- At risk of losing millions in federal funds; awaiting federal guidance

## FY22 Budget Overview



- FY22 General Fund total: \$530,279,092
- A 2.6% increase
- Much of what this budget will accomplish as "new" was included in the FY21 budget but frozen because of the uncertainty of COVID-19

- Increases for Hampton City Schools
- Increases to fight crime
- Investments in our housing stock
- Investments in flood mitigation and prevention efforts


## **Educated and Engaged Citizens**

"School funding increased annually in FY 2014 so the school system could provide personal technology to all students in middle school and high school.

That funding, and its implementation, put this City in a much stronger position when learning shifted to virtual last March."







## Educated and Engaged Citizens

- \$80,165,119 local funding
- That includes \$34.2 million more than the required local contribution determined by the state
- Increased capital for maintenance

## Living with Water

- \$1.00 per month increase in the Stormwater Fee
  - 80% dedicated to storm water maintenance
- Reduce flooding
- Reduce pollution in Chesapeake Bay





## Placemaking


- 2 Neighborhood Centers
- Return to normal operations of recreation programs, parks, libraries, museums and art facilities
- Neighborhood improvements and support





## **Good Government**

- Over \$36 million in road resurfacing, traffic signal improvements and pedestrian improvements over the Five-Year CIP
- Reconstruction of Little Back River Road & Armistead Avenue
- Financial systems replacement







## Employees

- 3% wage increase
- Adjusting pay scales to reflect the average of the region to retain experienced staff
- Minimum wage increase to \$11/hr.
- Merit bonuses





## **Taxes and Fees**

- No general tax increase
- Increase of \$1.00 per month for Stormwater User Fees (for homeowners; commercial fee depends on impervious surface area)
- Monthly increases in the sewer surcharge of 28 cents and in the usage fee of 33 cents (both per hundred cubic feet of usage).
  Average total increase for homeowners of \$4.07 per month.





## If the state fulfilled funding obligations

The tax rate could be about 69 cents rather than \$1.24
