

Stormwater Fee Increase Drivers

• Resilient Hampton ...

- \$12 million in projects bond-funded each year
- Monthly fee last increased \$1.00 in FY 2021
- Reduce neighborhood flooding with enhanced stormwater systems and maintenance.
- Increased operating and maintenance expenses due to capital projects and future stormwater initiatives.



Stormwater Fund Balance Current vs. Projected Fees



Planned

- Use \$1.5 million of our fund balance to lessen fee increase to customers in FY 2022
 - decreasing our fund balance from \$6.9 million to \$5.4 million
- Adopt the stormwater fee: \$1.00 increase for FY 2022
 20 cents for Resilient Hampton and 80 cents for Stormwater Program
- Review projections of expenses and revenues for FY 2024 and beyond





Wastewater Program

- Our Team's mission is to protect public health, water quality, and the environment by operating and maintaining wastewater collection.
- Our Wastewater Team operates and maintains Hampton's wastewater system and network of infrastructure.
 - Wastewater Collection System Maintenance
 - Pump Station Maintenance
 - Construction Projects
 - Fats, Oils, and Grease Reduction Program
 - Rehabilitation of our Wastewater Infrastructure

What's the Difference between HRSD & Hampton Wastewater Systems?

- We manage the City's wastewater collection infrastructure, which feeds into HRSD's wastewater treatment infrastructure.
- HRSD serves as the region's wastewater treatment facility.
 - HRSD's service area covers 17 cities and counties of southeast Virginia.
 - 9 major treatment plants in Hampton Roads.





Wastewater Rate Increase Drivers

- Regional Memorandum of Agreement (MOA) capital costs
 - Goal: Minimize sanitary sewer overflows and impacts to the Chesapeake Bay
 - Implementation has been delayed due to negotiations between HRSD and EPA (SWIFT)
 - Estimated repair/replacement needs are ~\$200 million (2021 Dollars)
 - Gradually spread over 20 years as we need to be more aggressive with our schedule
- Wastewater Surcharge last increased in FY 2013 (MOA)
 - Increased from \$0.44 to \$0.66 (per hcf 748 gallons)
- Wastewater User Fee last increased in FY 2009 (Operations)
 - Increased from \$1.07 to \$1.48


Wastewater Unrestricted Net Position Current vs. Proposed Fees

Recommendation

- Use \$1.0 million of wastewater unrestricted net position to lessen fee increase to customers in FY2022
 - decreasing unrestricted net position from \$3.4 million to \$2.4 million
- Use \$1.6 million of MOA net position to lessen fee increase to customers in FY2022
 - decreasing net position from \$6.8 million to \$5.2 million
- Adopt the sewer usage fee (33 cent increase) and surcharge fee (28 cent increase) for FY2022
- Review projections of expenses and revenues for FY2024 and beyond
