



- Offer city programs and tools for neighborhood improvements






City of Hampton: Total Part 1 Offenses Crime Rate Per 1,000 Population 2012-2016



2016 Regional Comparison Total Part 1 Offenses: Crime Rate Per 1,000 Population




2016 Regional Violent Crime Rate Per 1,000 Population








Weapon Violation Arrests Mid Year Comparison (January 1-June 30th)

Violent Crime Summit

Stakeholders

Hampton PD, Newport News PD, Department of Justice, FBI, DEA, ATF, Hampton Commonwealth Attorney Office, U.S. Attorneys Office, Probation & Parole, U.S. Marshals

Objective

Reduce crime, increase seizure of weapons, collaborative effort in prosecution to achieve stricter penalties

Execution

Unified effort, intelligence-based policing, develop dedicated investigative team to review/revive historical cases and conduct investigations on chosen targets. Monthly summit ensures information sharing between partners

National Integrate Ballistic Information Network (NIBIN)

- The Virginia Division of Forensic Science examines firearms for operability and compares bullets, cartridge cases, and shotshell cases to determine if they were fired from the same firearm, multiple firearms or specific firearm.
- Hampton Police and Newport News Police have submitted over 1,000 items each for analysis in 2016
 - As of June 30, 2017 Hampton has submitted approximately 391 items for analysis
- The Department of Forensic Science has just started analyzing items submitted in January of 2017, resulting in a turn around time of approximately 6 months
- New NIBIN Equipment will be housed in Newport News, staffed by NNPD and HPD
 - Supported by the ATF
 - Strive for 24-48 hour turn around time on submissions

Approach to Serial Shooters Initiative

- Multi-jurisdictional intelligence gathering to identify repeat offenders of violent crime
- Review of juveniles who have had frequent interactions involving narcotics and/or firearm-related incidents
 - Studies indicate juveniles will have a higher risk of engaging in firearm-related violence
- Prioritization of targets will fluctuate based on gathered intelligence and activities of targets









ConnectProtect Mobile App

- Grant funded Wason Fund for Public Safety via the Williamsburg Community Foundation
- Available for free in iOS and Android formats
- Push notifications whole city, geo-fenced areas, or a specific sections of the City
- Citizens can send in non-emergency tips which can include geo tagged photos or videos
- 75 tips received since May 6, 2017





Property Management

Rental Inspections: Goals

- To ensure dwellings meet safe, decent and sanitary living conditions
- Districts defined per state code guidelines



Rental Inspectors' Activity

- Rental inspectors in the districts conduct:
 - Regular property maintenance inspections
 - City code and zoning violation inspections
 - Inspections when the tenants file complaints through the 311 Call Center
 - Pro-active inspections looking for rental signs, looking at ads for rental property, etc.

Rental Inspectors' Activity

- Since last year's update, rental inspectors have:
 - 430 rental inspections conducted
 - 90 first time inspections
 - 61 violations were identified from first time inspections
 - 340 total re-inspections have been conducted
 - 400 inspections have been closed or completed
 - 30 are still pending

Rental Inspection: Challenges

- Ongoing Challenges:
 - Identifying unregistered rental properties
 - Compliance with inspections
 - Gaining access for re-inspections
 - Time-consuming process
 - Unable to issue summons to out of state owners for violations

Rental Inspection Expansion

- Expanded the rental inspection in Phoebus area
- Citizens requested the expansion based on the success of the program
- Area met the established criteria
- Closed the an unintended gap in the district between North Phoebus and South Phoebus

Hotel Ordinance: Goals

- Ensure that only hotels with sufficient facilities are used as long-term housing
- Ensure that minors staying in hotels are identified and given access to education
- Find safe and sanitary housing alternatives for those in need

Hotel Ordinance: Results

- Every motel received permit the first year
- 5 motels approved for extended stays
- 100% of extension applications received from residents in motels approaching 30 day stays were screened and assessed for homeless services

Hotel Ordinance: Results Since Last Update

- 21 extension applications received
- 11 extension applications approved as homeless
 - 3 approved as families with children. 2 received housing services and 1 self resolved
 - 8 individuals approved. 1 received housing services and 7 self resolved.
- 10 denied extensions (not considered homeless)
 - Reasons not considered homeless:
 - Working and hotel is near employment
 - Out of town worker and needs a place to stay temporarily, longer than 30 days referred to 311
 - Loss of contact after form received

Hotel Ordinance: Trends

- Enhanced staffing:
 - HCS Race to Graduation staff to ensure housing options for displaced youth
- Ordinance changes were enacted last year to help with monitoring compliance
- Extension applications mailed to hotels yearly to ensure compliance

Neighborhood Initiatives

Neighborhood Goals

- Build positive relationships with neighborhood leaders and organizations in targeted areas
- Build capacity (knowledge, skills & abilities) of neighborhood leaders & organizations

Neighborhood Characteristics Positives

- + Desire to work with police and city
- + Desire to learn new skills and engage
- + Desire to focus on children and families

Neighborhood Characteristics Challenges

- Several neighborhoods are in transition
- Changing leadership
- Limited communications structure
- Few social interactions
- No schools in 4 neighborhoods

Current Efforts to Address Challenges

- Capacity Building for Neighborhood Leaders and Organizations
- Increasing Opportunities for Social Interactions

Capacity Building


- Neighborhood leaders
 - Coached with formal & informal leaders Neighborhood organizations
 - -Established communication structures
 - Trained neighborhood watch organizations
 - Registered neighborhoods and neighborhood serving organizations

Increased Social Interactions

- Housing Blitz (Old North Hampton)
- New Special Events Rules trying to increase smaller neighborhood focus events
- Community Explosions
- North Phoebus Community Day of Service
- ABCD Pilots in Phoebus and Shell Road

Next Steps

- Incorporating the Asset Based Community Development Model
- Pilot Programs underway in North Phoebus and Shell Road
- Partnerships with the community, faith based, civic and governmental entities

ABCD Shell Road

- Identified concerned community members (Community Connectors)
- Organizing meetings to identify assets (Convening that was open to the public)
- Identified areas of concern
- Organized Community Action Teams (CATs)
- Begin to meet in CATs to discuss solutions to address challenges

ABCD Shell Road

- Identified concerned community members (Community Connectors)
- In partnership with Neighbor Commissioner surveyed residents about assets and concerns
- Conducting "Host Home Meetings" throughout Wythe
- Helping to develop relationships and discussion early in the process

ABCD Challenges

- Complete paradigm shift for all involved
- Residents understanding that this effort is about what residents are willing to do to address issues with staff support (not about what they think the City should do)
- Staff understanding that they cannot dictate or control the feelings of residents
- Staff understanding that there are things that fall outside of the ABCD process that the City will do in these areas

Change Youth Violence Prevention Title

- Proposing a name change...
- From "Youth Violence Prevention Office"
- To the "Office of Youth Opportunities"

Reason for the Change to "Office of Youth Opportunities"


- New name more accurately reflects the work of the office
- Youth Violence Prevention to some has a negative connotation
- Old name may have inadvertently:
 - inappropriately stereotyped young people
 - Served as a deterrent for participation by youth
 - Served as a deterrent for participation for community partners
 - Not accurately reflected the daily work
