This project identified a portion of 44HT0121, an apparent late-19th to early 20th century domestic occupation.  
However, due to the nature of this project, site boundaries could not be fully delineated. DHR concurs with the consultant's recommendation that the portion of the site within the area of potential effects (direct) does not contribute to the eligibility of the site as a whole for listing on the National Register of Historic Places due to the nature of the artifacts and soil disturbance. However, if the project lease area or access road is adjusted, additional archaeological investigation will be required.
