# Project Narrative Form

### Project Narrative

# Demonstration of Need\*:

The City of Hampton and the Commonwealth's Attorney's Office of Hampton are continuously dedicated to reducing violence and crime within the community. The Commonwealth's Attorney's Office is committed to addressing the epidemic of gun violence and other violent crime that has taken the lives of many individuals in the City of Hampton.

Therefore, The Commonwealth's Attorney Office is seeking funding to assist in the several components of Operation Ceasefire for the City of Hampton. Hampton, Virginia is a larger medium-sized urban city with a population of 137,746 people and 37 constituent neighborhoods. According to Neighborhoodscout.com, the chances of becoming a victim of either violent or property crime in Hampton, Virginia is 1 in 37.

Most of these individuals involved in violence are disconnected from social support, unemployed, not in school, and have been exposed to trauma - all significant risk factors for being a victim or perpetrator of gun violence.

For example, a study that examined 500 African American youth in Hampton Roads, Virginia found that direct exposure to violence was the best predictor of whether an individual would later engage in gun-related crimes.

While large segments of the population are severely impacted by exposure to violence within their communities, small groups are responsible for the majority of violence. Research from multiple cities across the country suggests that small networks of individuals - sometimes as few as a hundred - are responsible for the majority of homicides and shootings. For example, in Oakland, 0.3% of the city's population was responsible for 85% of the city's homicides. Identifying these networks - specifically the "Trigger Pullers" - responsible for Hampton's firearm violence is crucial in reducing shootings within the city. In Virginia an average of 1,065 people die by guns with a rate of 2.2 deaths per 100,000 people; Virginia has the 34" highest rate of gun-related deaths in the US. Gun violence and violent crime as impacted the Hampton Roads area.

A review of violent crimes in the City of Hampton from 2009 - 2021 identified African American males dispropo1iionately were the victims of violent crimes. Within that same range, 53% of all firearm-related homicide victims were under the age of 25. Victims of violent crimes are more likely than others to engage in violence and reside in communities where violence occurs. Between 2009 - 2019 offender data on firearm-related homicides identifies 67% of all offenders under the age of 25. Youth victimization is not just limited to homicide year over year data evidence black males between 12-25 are disproportionately victimized by gun violence. With a national homicide rate of 5 per 100,000 citizens, Hampton a city of nearly 140,000 has had at least 5 youth or young adult murders since 2010.

According to one of our community partners, the Office of Youth and Young Adult Opportunities fielded a survey created by researchers at Christopher Newport University's Center for Crime, Equity, and Justice Research and Policy (CCEJRP). The survey aimed to better understand community members' perceptions of the causes and effects of crime and safety in the City of Hampton, with the goal of aligning the city's work with community needs. Most surveyed perceived unsupervised youth, drugs, and mental health/well-being as the top three contributors to crime. The survey also identified the considerable gap between individuals knowing and using available community resources as an additional factor. Further, survey respondents shared widespread concerns about gun accessibility for high-risk individuals and crimes occurring at night.

After gaining community and stakeholder input, government officials and city leaders met to determine the causes and sub-causes of gun violence. Participants believed that disproportionate areas of gun violence or "hot spots" and vulnerable individuals inundated with several complex challenges, resulted in increased gun violence. Some additional causes include econon1ic disinvestment, blight, concentrated poverty, family dysfunction, poor conflict resolution, unaddressed trauma, substance abuse, criminal justice. system practices, and community desensitization.

The Hampton Commonwealth's Attorney's Office believes Operation Ceasefire funding is necessary to combat gun violence in the City of Hampton. The funding will assist with building much-needed evidence-based initiatives to reduce violence, educate on gun violence, enforce criminal activity in the community and improve mental health for juvenile victims of gun violence and homicide.

#### **Project Description\*:**

The Commonwealth's Attorney's Office is seeking to utilize the three major components, prevention, intervention, and enforcement components of Operation Ceasefire. Each component will have a specific program(s) to meet the necessary requirements of the grant: Prevention: Junior Commonwealth's Attorneys Summer Program (JCAP) and Educating Kids about Gun Violence (EKG), Intervention: Youth Violence Support Group, and Enforcement: Call-Ins.

In an effort to reduce crime and violence, early intervention research programs such as the Junior Commonwealth's Attorney Summer Program (JCAP) work to strengthen crime prevention and educational outreach. This is a free opportunity to allow students a chance to engage and interact with criminal justice professionals such as judges, attorneys, and law enforcement. Students will participate in an exciting and engaging curriculum to include courtroom observations and field trips to the Supreme Court, Hampton Police Department, Virginia State Capitol, Hampton Courts, and Office of the Attorney General. This one-week summer enrichment program for youth introduces students to the criminal justice system in a safe and non-confrontational environment. Inclusive to students from all walks of life, the mission of JCAP is to build transformative relationships while educating and engaging youth in a variety of crime prevention topics including conflict management, gun violence, gang prevention, neighborhood safety, substance abuse prevention, dating violence awareness and prevention, and internet safety.

Educating Kids about Gun Violence (EKG): The Educating Kids about Gun Violence (EKG) program was developed in response to high levels of gun violence in an urban inner-city through a partnership between the county prosecutor's office, law enforcement, and a Level I Trauma Center in Indiana. The Hampton Operation Ceasefire will adopt the existing model of EKG and implementation, coordination and planning will be conducted by the Program Coordinator. The Program Coordinator and selected participants will receive training and utilize the existing curriculum and other tools of the Fayetteville Operation Ceasefire Program. Those trained on this curriculum will include the Operation Ceasefire Program Coordinator, Commonwealth's Attorneys, Hampton Police Officers, medical personnel, and other individuals from partnering agencies who may qualify to offer the instruction. This program will be conducted in Hampton City Schools and the community. EKG will be presented multiple times during each quarter to students, parents, and the community.

Intervention: Youth Violence Support Group(YVSG) In Hampton, youth and young adults are overwhelmingly the targets and perpetrators of violence. Victims and witnesses fear retaliation for cooperation and routinely report being hesitant or unwilling to testify in court. Court cases

notwithstanding many victims and witnesses underreport their victimization out of concern for safety and a belief that cases will not be prosecuted to their satisfaction. As such a segment of the population does not benefit from victim services and has unaddressed traumas. Acknowledging these challenges as a disconnect between the public and the available services we aim to increase engagement and impact with a Youth Support Group.

Group Violence Intervention-Call Ins and/or Custom Notification. According to the National Network For Safe Communities at John Jay College, the Group Violence Intervention (GVI) reduces homicide and gun violence, minimizes harm to communities by replacing enforcement with deterrence, and foster a strong relationship between law enforcement and the community. Operation Ceasefire funding will allow the Commonwealth's Attorney's Office provide Call Ins and Custom Notifications to meet resource partners and law enforcement officers face to face. Offenders attend call-ins by "invitation-only". If an offender gets an invitation it means they are already on local, state, and federal radars.

### Service Area/ Target Population:

The Hampton Operation Ceasefire program will serve several populations in Hampton. The Junior Commonwealth's Attorneys Summer Program will provide prevention strategies to Hampton City, private, and homeschooled students. This will include students who are from various socioeconomic backgrounds and those who are deemed at risk of being offenders or becoming victims of crime. Next, the Educating Kids about Gun Violence(EKG) program will serve as another prevention strategy and be presented with the approved curriculum to students in high school and to the general public including parents and citizens of the community. The third population to be served utilizing the intervention strategy will be youth and young adults between the ages of 12-25, who have witnessed violence and/or are crime victims will be enrolled in our Youth Support Group. Lastly, the fourth population to be served are those involved in gangs and criminally active groups who are identified through a multi-agency partnership. Those identified become the targets of a three-pronged approach: law enforcement, the threat of enhanced prosecution, and access to social services.

#### Sustainment Plan:

The Commonwealth's Attorney's Office is a well-established organization whose sole responsibility is to prosecute criminal cases for the city of Hampton. The successes of this office are a direct result of the forward-thinking leadership through the years that recognized the needs of those who were victimized by violent crime in this community. In 1984, the Commonwealth's Attorney's office was one of the first in Virginia to establish the Victim Witness Assistance Program with funding through the Department of Criminal Justice Services and the City of Hampton.

Through other VOCA-funded grants, the office has implemented

additional programming benefiting victims and the community such as the Rapid Engagement and Support in the Event of Trauma (R.E.S.E.T.) program and a Homicide Survivors Support Group. In addition, the Commonwealth's Attorney's Office receives and manages several other DCJS-administered grants including the Virginia Sexual and Domestic Violence, VSTOP, Operation Ceasefire, Operation Ceasefire Prosecutorial, and Witness Protection. Some of the past grant opportunities that the office received include the Byrne Justice Assistance, American Rescue Plan Act and Coronavirus Emergency Supplemental Funding grants.

The Commonwealth's Attorney's grants management team oversees grants and assists with the implementation of new programming created by the office. The team is comprised of the Director and Assistant Director of Victim Services who collectively have over 50 years of experience with the Hampton office. They both have extensive knowledge of program management, grant writing, supervision, and technical and training capabilities that benefit the execution of programming in the office. The team ensures that all grants remain in compliance of grant requirements including the timely submission of progress reports. The Program

Coordinator will report to the grants management team to ensure that all grant requirements are successfully met.

The Hampton Commonwealth's Attorney's Office has continued to demonstrate a commitment to being fiscally responsible for over \$1.4 million in grant funding and are more than capable of developing and enhancing new program objectives for the proposed project.
