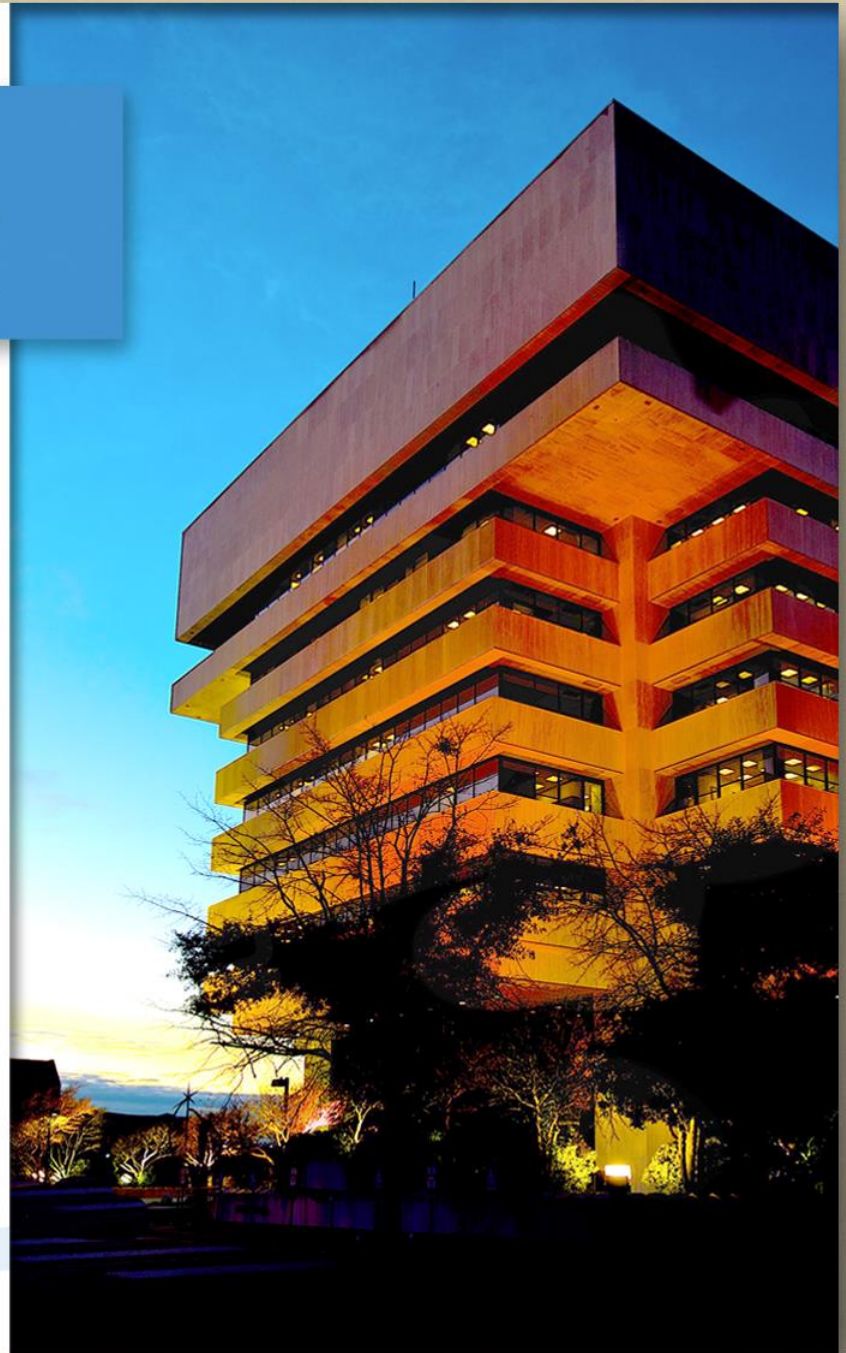

# I Value input through the years

- FY11: Needs vs. wants
- FY12 Broad service levels: Maintain, reduce, eliminate
- FY13: Tolerance for specific cuts
- FY14: Increase revenues/Invest in city and schools or make dramatic cuts/disinvest  
*87% said no further cuts, so rate was increased.*

# I Value input through the years

- FY15: Polling on strategies to grow revenue, philosophy of tax bill equalization
  - 73% backed moving tax rate up to compensate for decrease in values, but rate wasn't changed
- FY16: Fee increases for solid waste, stormwater
- FY17: Town hall-style forums
- FY18: Proposed police increases, fees, strategic priorities, thoughts on future

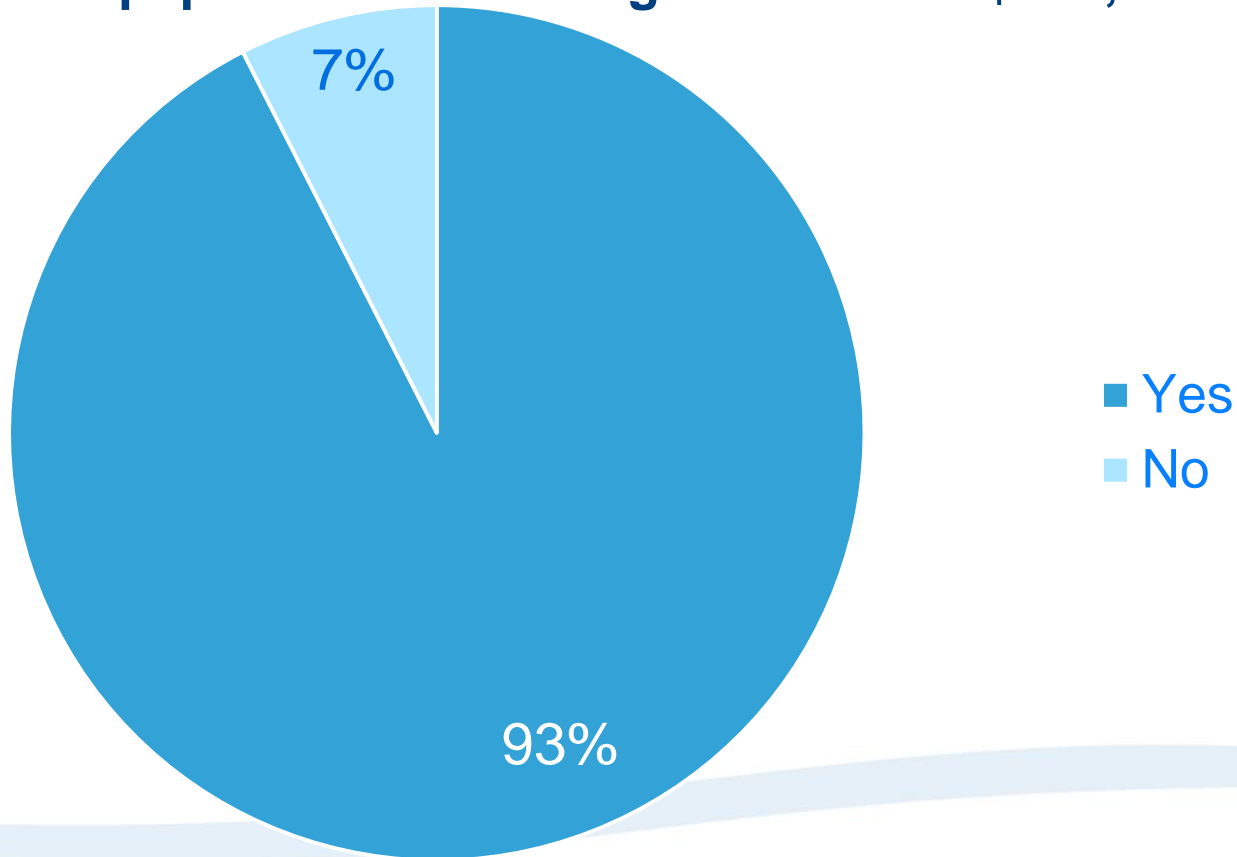


# Police increases

- Crime has been increasing in Hampton – as it has in the region and much of the nation. The Police Chief is working on many fronts to combat that trend but has asked for technology upgrades and more personnel so they can continue in the proven community-policing model.

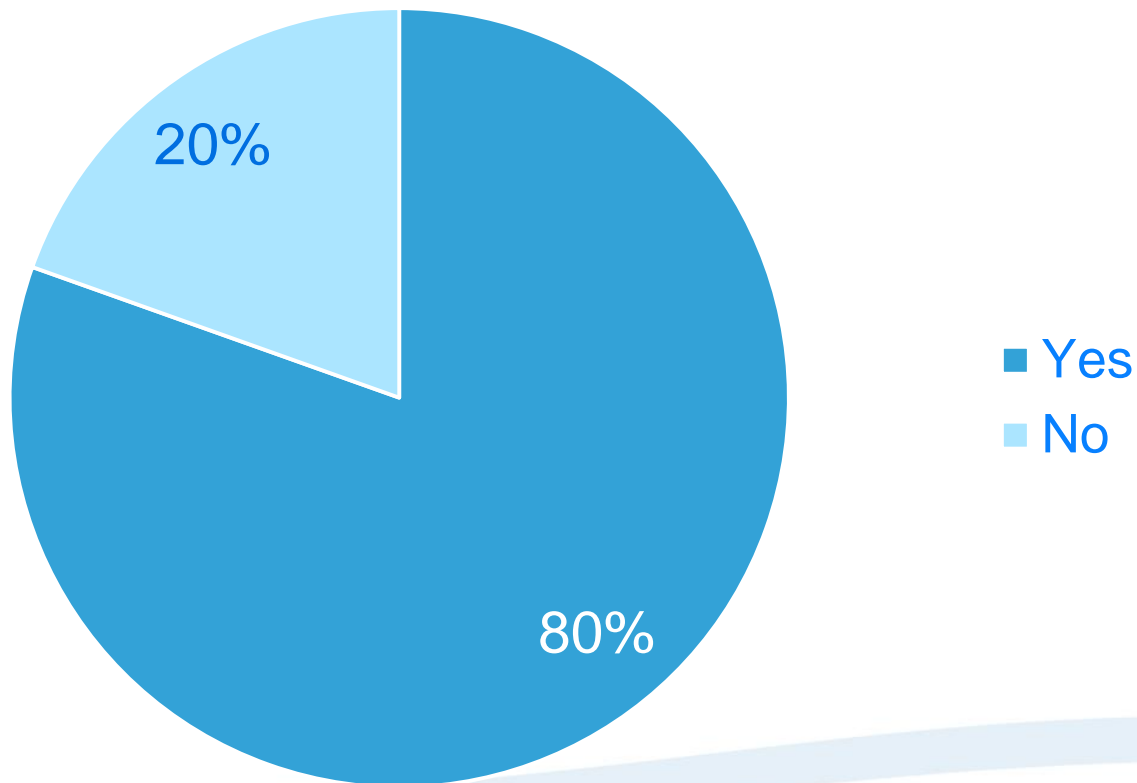
# Police Increases: Polling

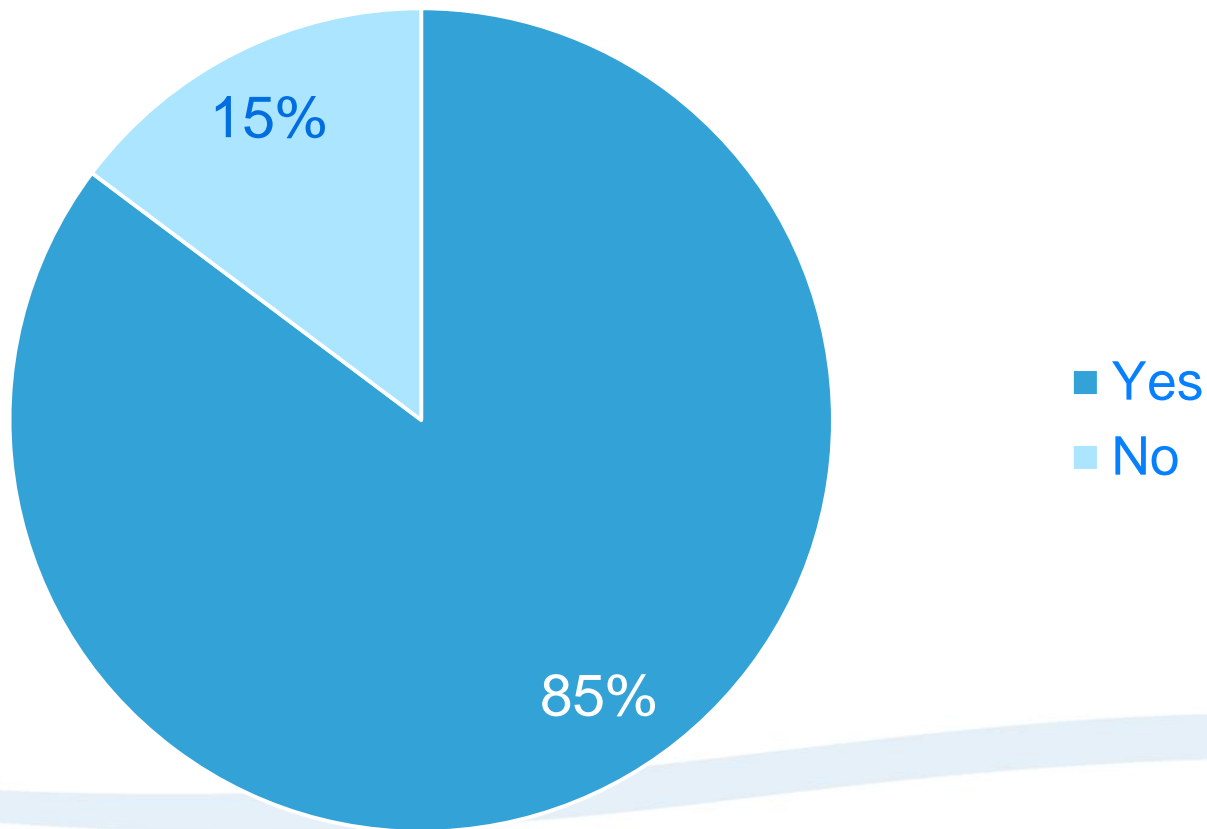
# Police Increases: Polling

# Recreational vehicles

- Hampton effectively eliminated taxes on recreational vehicles and campers in FY10. Some of this was in reaction to a continuation of the elimination of the boat tax.
- Now that the city has added a boat fee, some residents have called for the restoration of the tax on motor homes, recreational vehicles and campers.

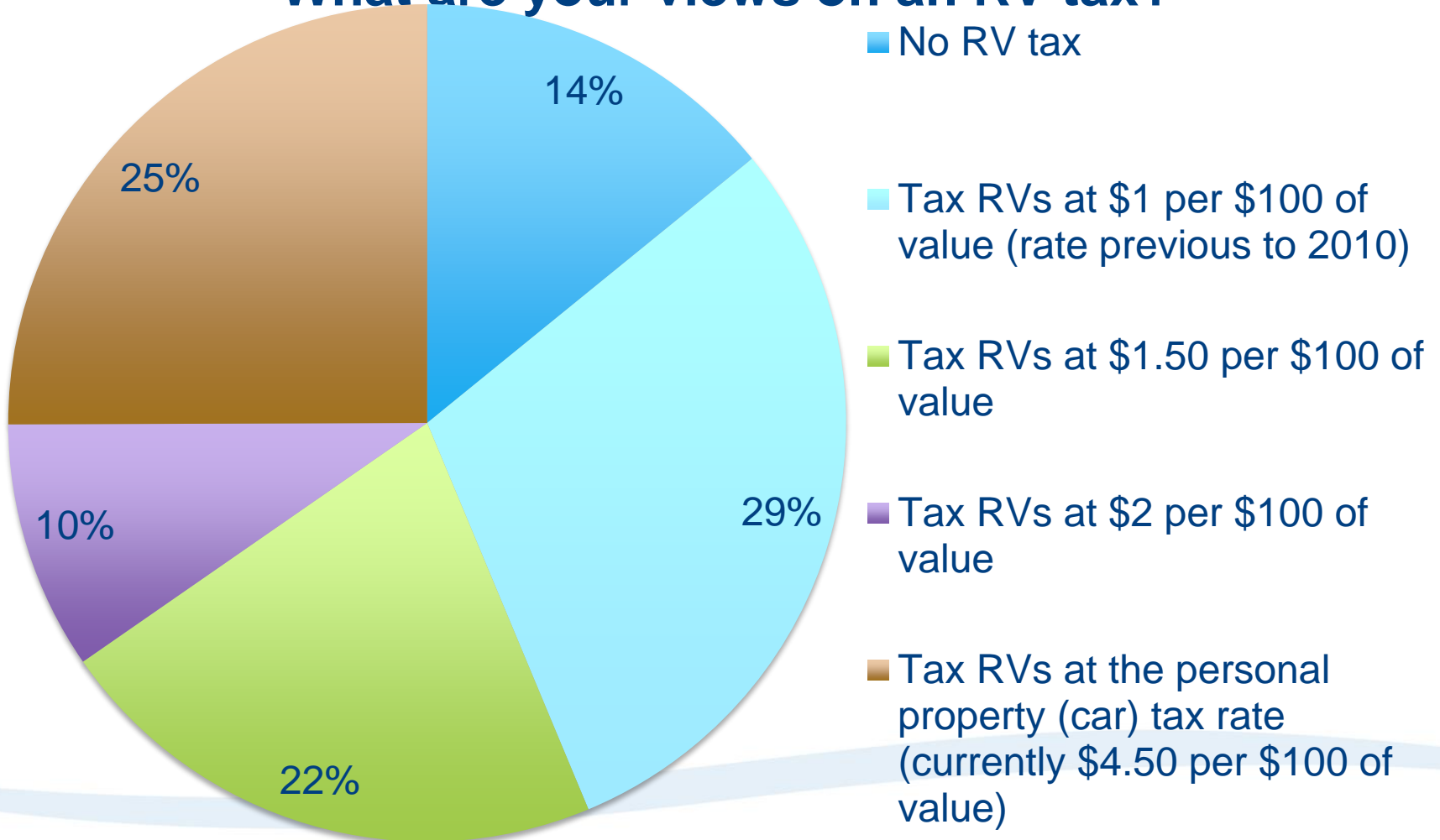

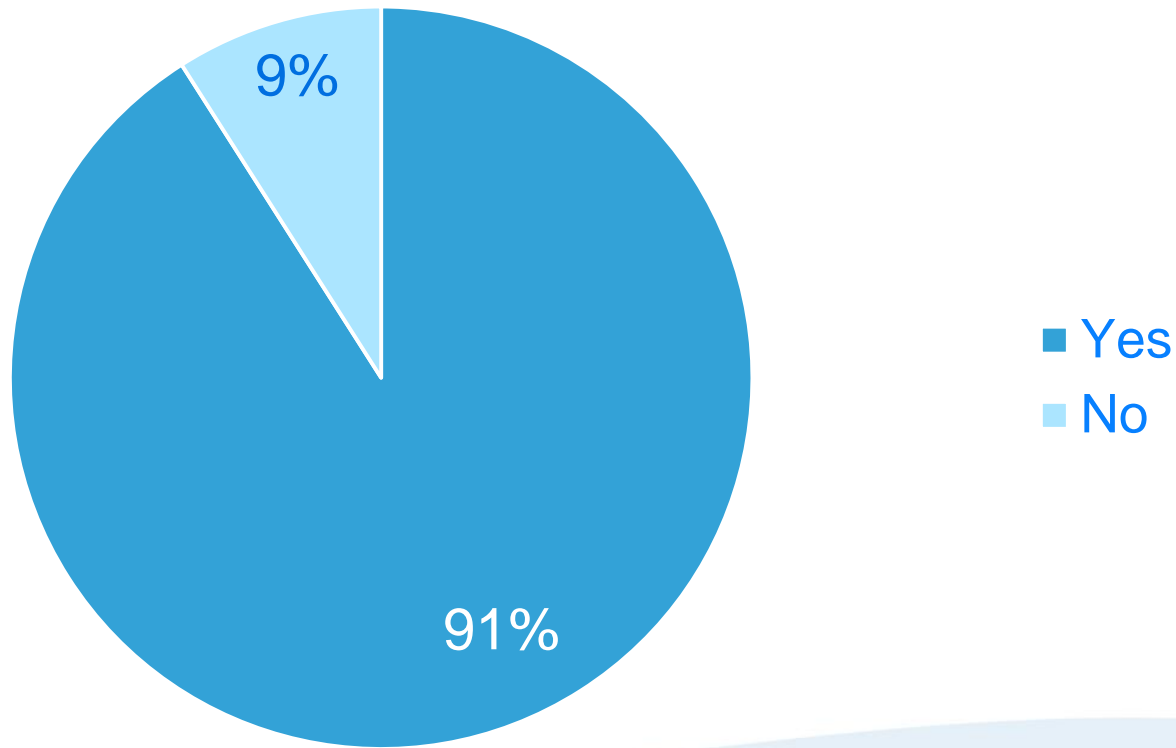


# EMS fees

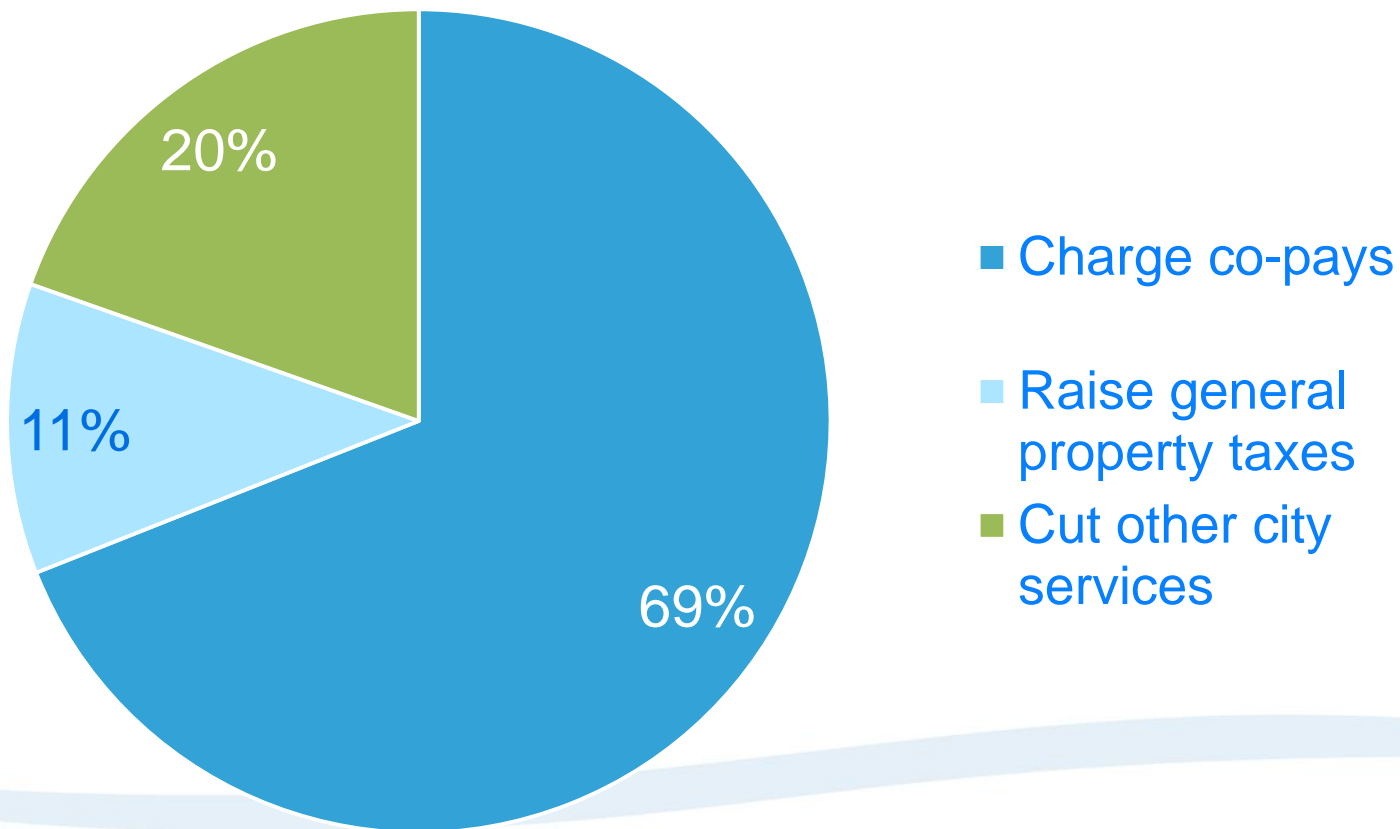
# EMS Fees: Polling

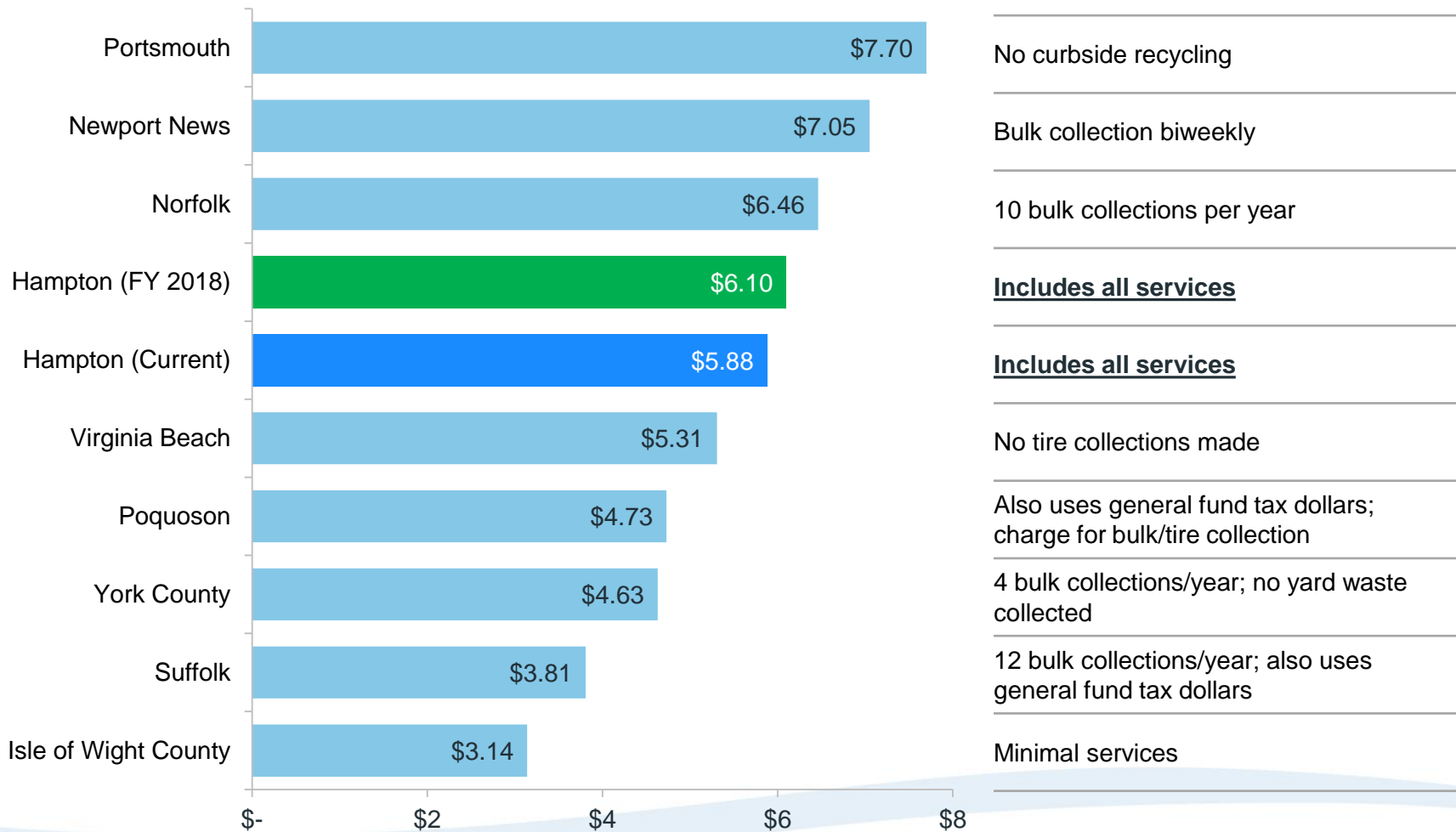
**How should we make up for EMS revenue that will be lost due to high-deductible plans?**



# Trash fee guiding principles

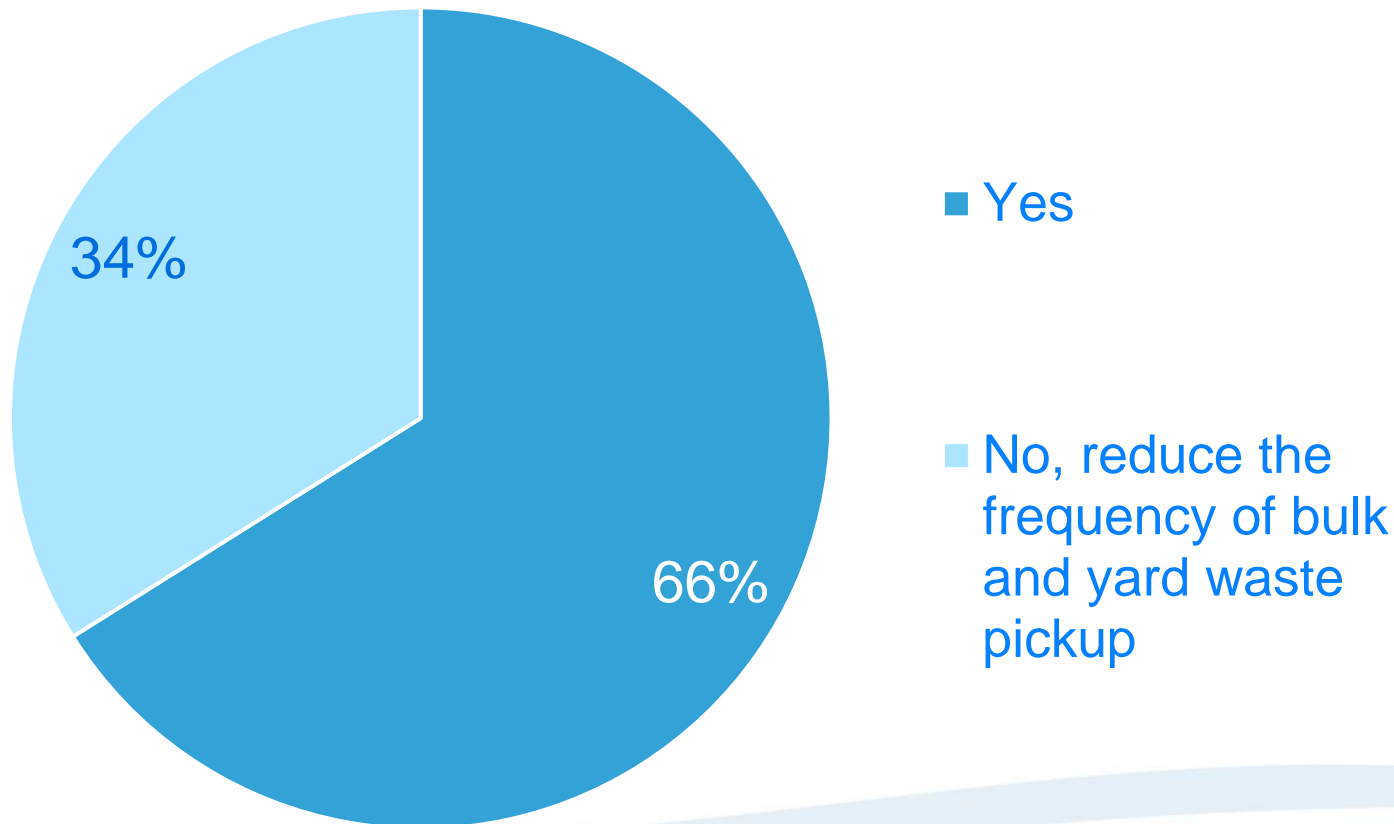
- Solid waste operations should be financially self supporting (user fee should support the operation)

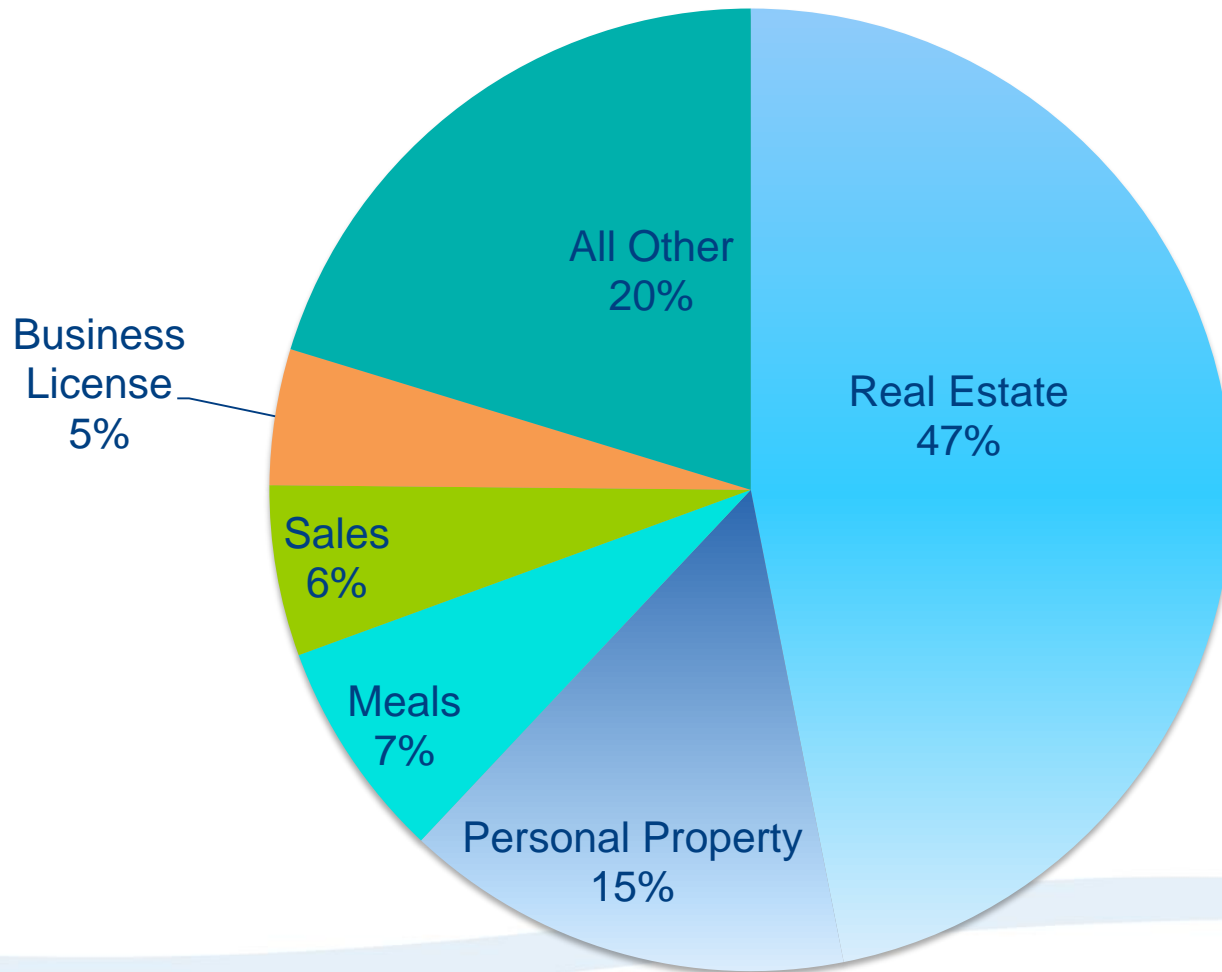

# Philosophy for the future

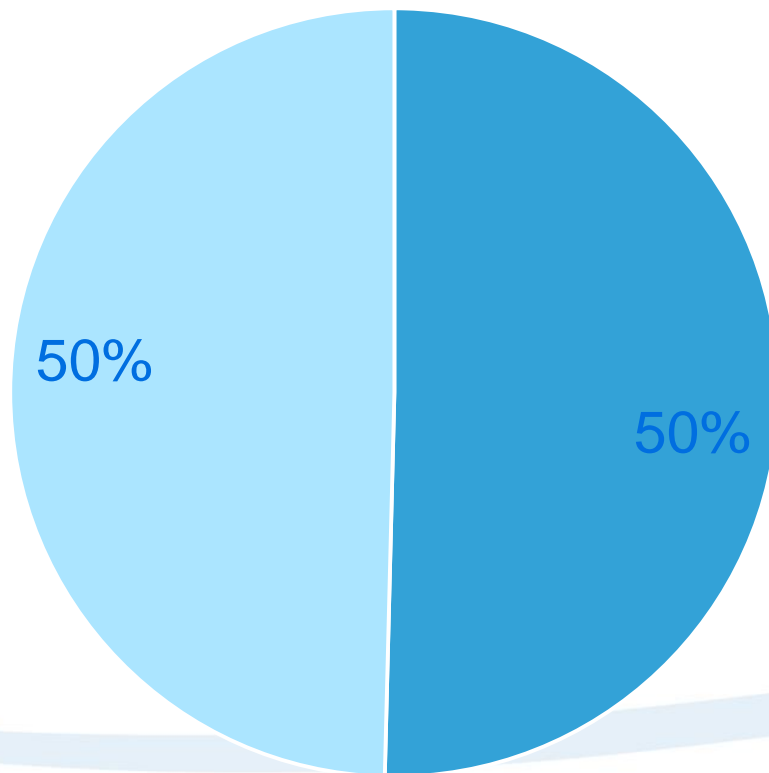
- After several years of declining revenue due to national housing trends and a recession -- and after years of city cuts -- residents said in polling that they did not want more service cuts but wanted to invest in future programs.
- If property values continue to grow at a slow 1%, rather than beating inflation, the city will soon be at a crossroads again of looking at cuts to popular and valuable services or revenue increases. These will be hard choices for residents.

# Philosophy for the future

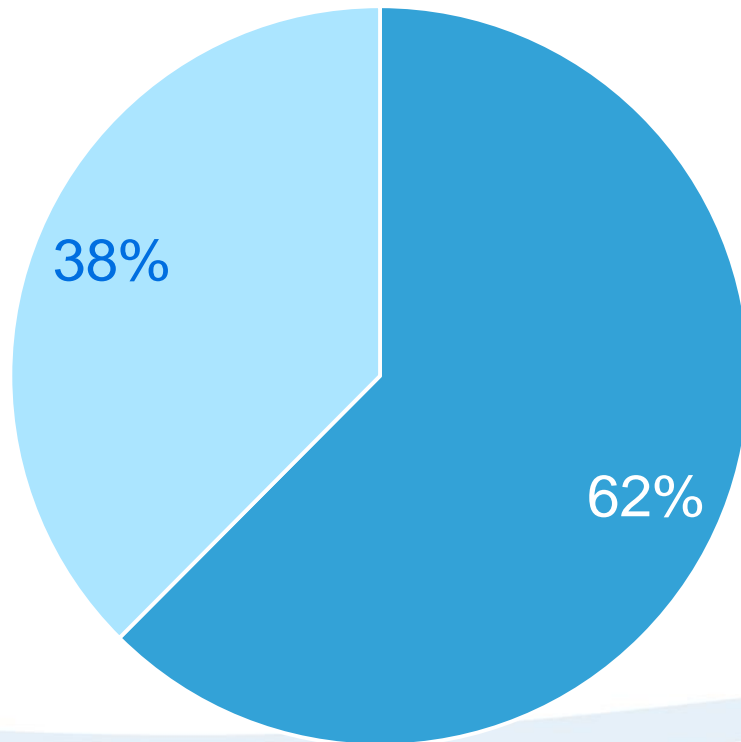
Which of the following best describes your philosophy of as we approach this choice?

# City's role in development

- Nearly built-out city/little vacant land
  - Development here means redevelopment
- Wetlands limit buildable land
- Have larger parcels to respond to commercial interest (EDA)
- Infrastructure ready
- Council goals: Jobs, tourism, higher-value housing, retail

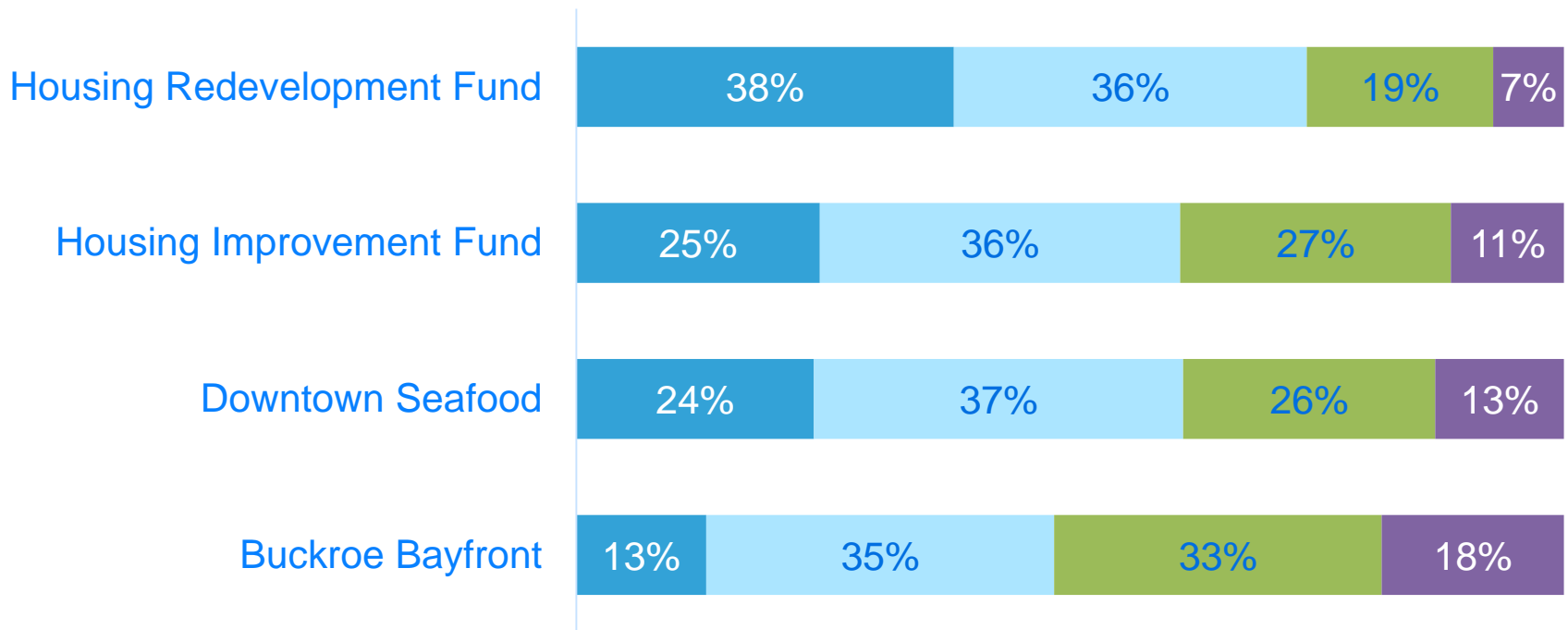


# Strategic capital spending

- New spending beyond the mostly maintenance-level spending
- Council has agreed to spend about 75% of these funds for projects designed to boost economic growth in order to help grow the tax base for future years.

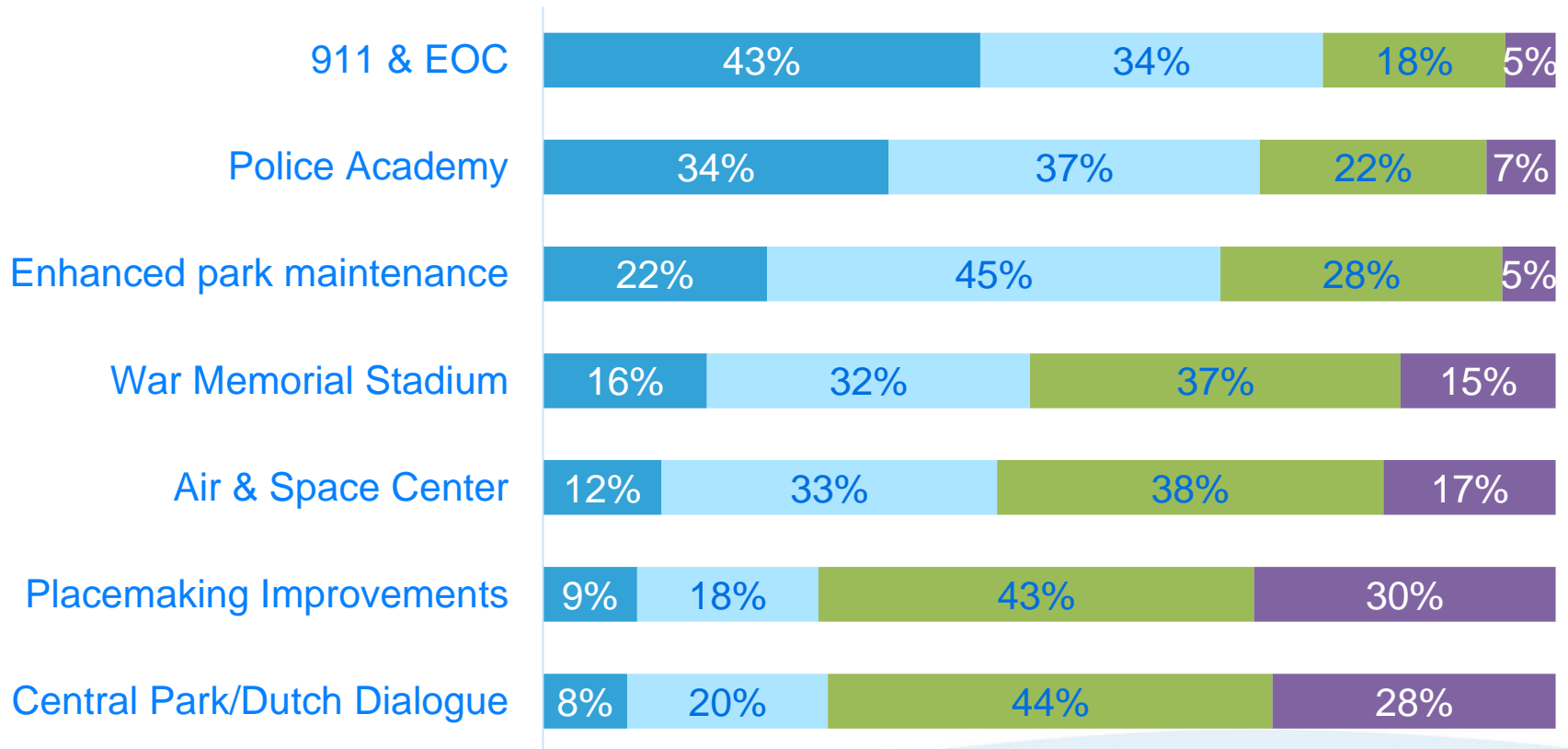
# Strategic: Tier 1 - Economic growth

■ High ■ Moderate ■ Low ■ Not a priority



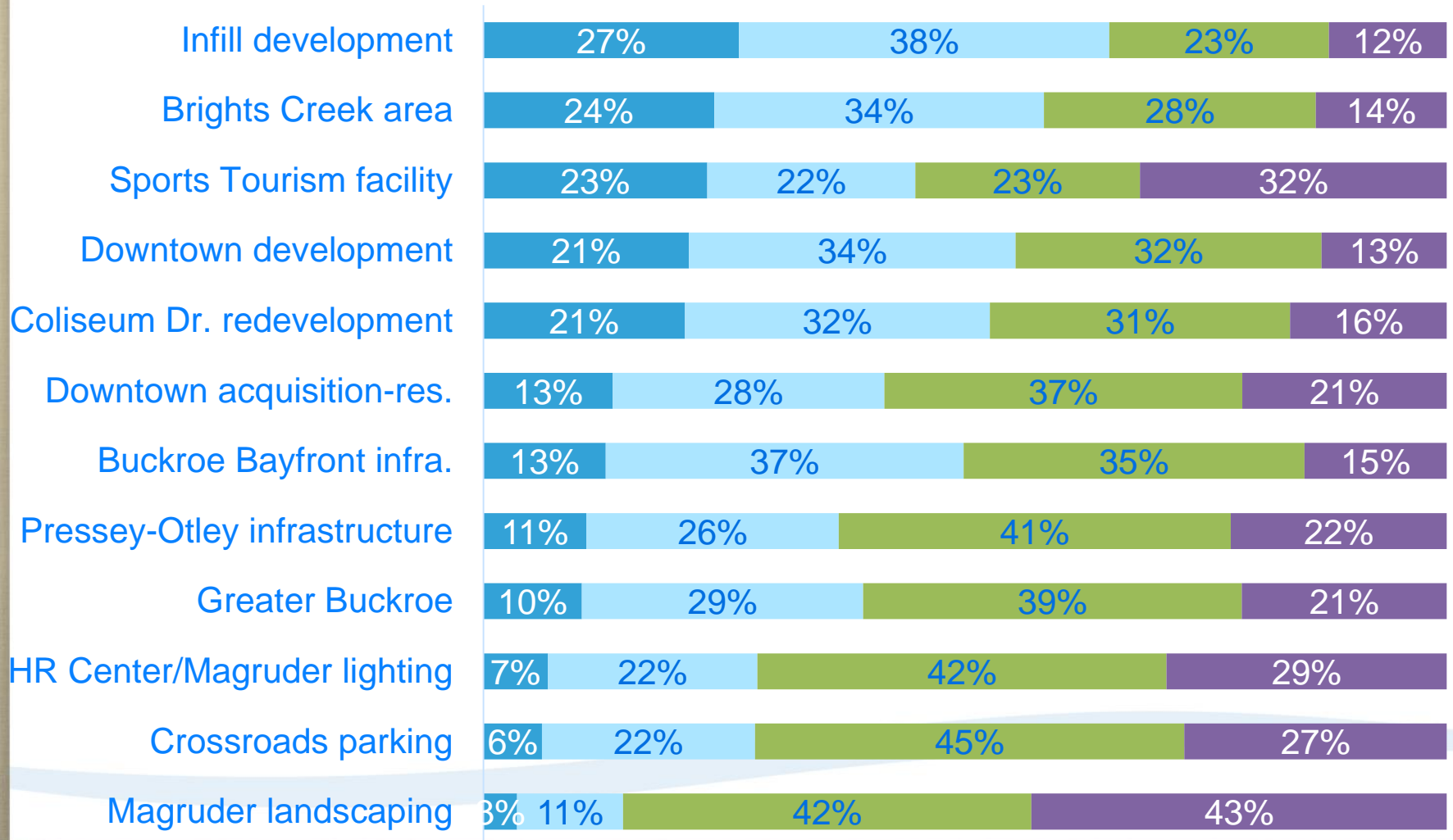
# Strategic: TIER 1 - Other

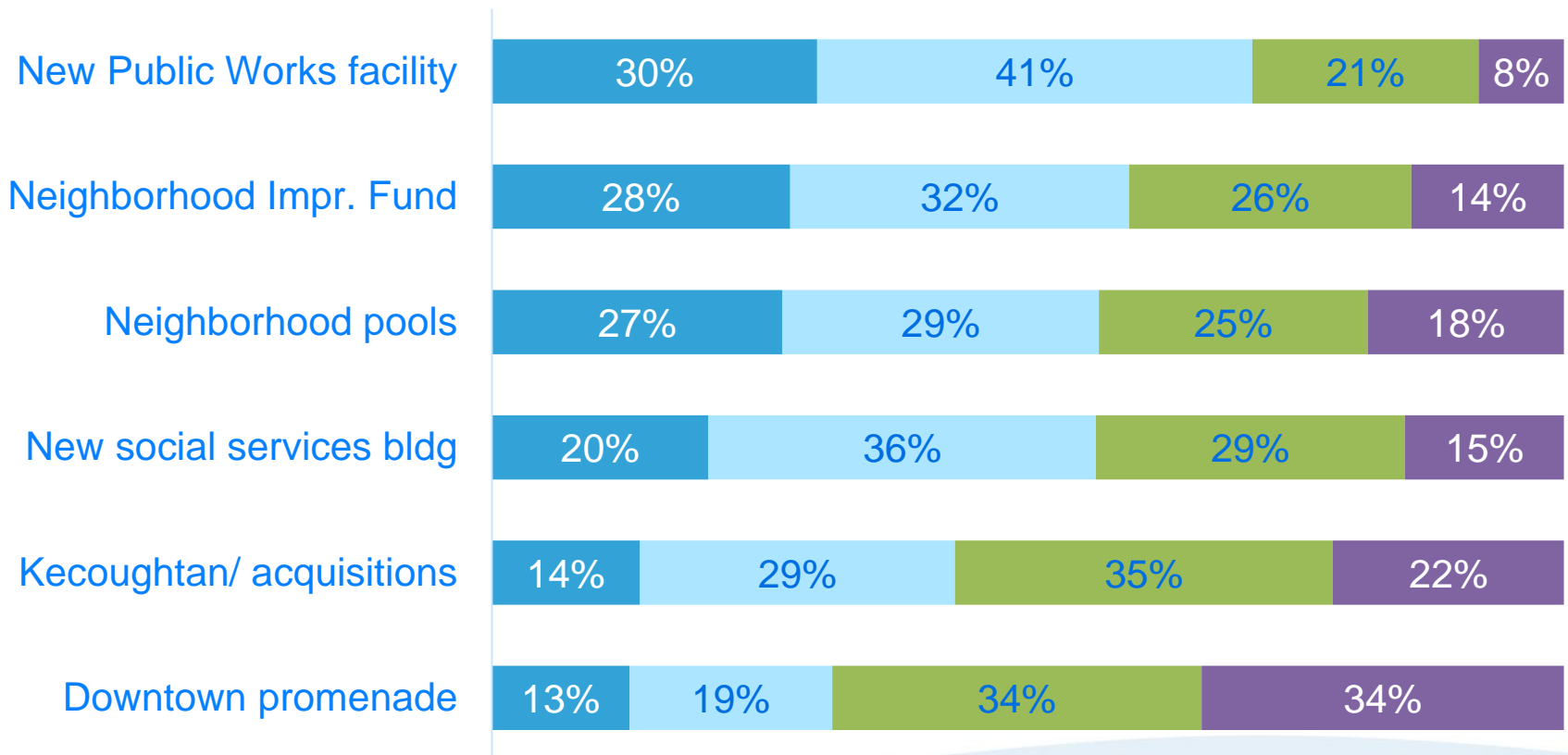
# Strategic: TIER 2 - Economic
