Applicant Region Description:	Established in 1610, Hampton is one of America's oldest cities with a proud and rich history. The City of Poquoson was founded in 1975 and is the oldest continuously named city in Virginia. Hampton & Poquoson are adjacent localities along the Chesapeake Bay and have miles of shoreline, which contributes to over half of Hampton being located in a Category 1 or 2 surge zone and most of Poquoson being located in a Category 1 storm surge zone.
	Demographics: Hampton is 52 square miles with a population of 137,436 and Poquoson is 16 square miles with a population of 12,157. Nine percent (9%) of families in Hampton live below the poverty level. Eleven percent (11%) of the population is over 65 years of age in Hampton and fifteen percent (15%) of the population is classified as having disability status. Fifteen percent (15%) of Poquoson's population is over 65 years of age and eleven percent (11%) percent of the population is classified as having disability status.
	Hampton & Poquoson have a history of excellent outreach to their citizenry. Both Offices of Emergency Management have consistently conducted over 30 outreach events each year.
	One of Hampton's most successful outreach initiatives is Safe & Clean Community. It was implemented in 2013 to target areas that had a high crime rate and high gang activity. Targeting these areas with over 7,000 brochures on preparedness information and interaction with city employees has led to cleaner and safer neighbors in these 9 districts.

This project addresses Virginia's THIRA item and Hampton Roads' THIRA item of a Category 3 Hurricane hitting the Hampton Roads area by creating a more prepared citizenry through training classes and outreach. It also addresses Virginia's THIRA item of a Natural Pandemic occurring by establishing a group of trained citizens to assess the community impact and possibly assist neighbors that would be affected by a Pandemic. Virginia's THIRA items of Flood and of a Winter Storm dumping 24 or more inches on Hampton Roads would also be supported by a prepared citizenry.

Risk Characterization Description:

Virginia's THIRA lists the threat of a Category 3 Hurricane striking Hampton Roads. This investment can lessen the impact on the population by getting information out to residents which will allow them to prepare for a major hurricane. This grant will also train volunteers to conduct basic search and rescue and medical care for residents so they can safely respond in their neighborhoods in the event that City resources are unable to reach them for an extended period of time. Volunteers could also assist with outreach and response during Pandemic Events, Floods and Winter Storms which are also listed under Virginia's THIRA, as well. This investment will also help meet the Virginia's THIRA Category 3 Hurricanes Public Information and Warning Core Capability goal by getting out accurate information to all residents through doorto-door outreach conducted by CERT.

This projects supports the Hampton Roads THIRA functional areas of Public Information and Warning and Community Resilience - Community Outreach. The Hampton Roads region has agreed that Citizen Corps would be a regional priority. This project supports CERT and CART which are two Citizen Corps programs.

This investment supports the following Emergency Support Functions in Hampton's and Poquoson's Emergency Operations Plans: Emergency Management–5, Mass Care-6, Public Health and Medical Services-8, Public Safety and Security–13, External Affairs –15, and Volunteer and Donations Management-17.

Additionally, the outreach and training that is conducted through OEM, OEM volunteers, and other departments has been shown to be effective in reducing gang activity and crimes in Hampton's nine (9) Safe and Clean districts.

Threat:

Based on data researched and compiled for the Hampton Roads Hazard Mitigation Plan, the natural hazards which pose the greatest risk to the Hampton & Poquoson are hurricanes, flooding, wind events, and tornadoes.

Hampton also has several high value terrorist targets, such as the Hampton Roads Bridge Tunnel, NASA, and Joint Base Langley Eustis. The police departments and emergency management are constantly reaching out to these partners to make sure there are not encountering any prevention or preparedness issues. Hampton and Poquoson Police Departments receive reports from the Virginia Fusion Center on a continual basis providing updated information on potential threats of all kinds to the region including terrorist activities.

Over the last few years Hampton has seen a rise in gang activity, which has led to multiple incidents of violence culminating in the shooting of two toddlers in two different incidents on the same street from stray gun fire. After this incident, the City started our Safe and Clean program which has relied on volunteers to reach out to residents of the nine (9) districts and promote prevention and preparedness activities, of which CERT & CART are two of the programs. Since the inception of Safe and Clean, the crime rate in the districts has gone down; however, we are now noticing a rise in gang activities in adjacent neighborhoods and are looking at expanding Safe and Clean to new areas.

The United States Air Force is planning to relocate an F-22 Squadron to Joint Base Langley Eustis in the summer of 2021 increasing the amount of air traffic and training flights over Poquoson and Hampton. In addition, the threat of domestic violent extremism from environmentalists and other groups opposed to military activities, the potential for civil unrest and workplace violence have increased the potential threat for mass casualties.

Describe the threat in the applicant region. Explain the proposal's nexus to terrorism, gangs, and/or violent criminal activity. Example: FBI reports that a state sponsored hacker is attempting to break into computers controlling transportation systems. Vulnerability:

Due to the advanced aviation and technological research that is conducted at Joint Base Langley Eustis and NASA Research Center in Hampton, these facilities are targets for attacks. We have found that there is great interest at both facilities for CERT training. Many of our new CERT members are military personnel. While they received other types of training, they have found CERT training to be particularly useful in day to day incidents like a sudden loss of power or kitchen fires.

Hampton is extremely vulnerable to flooding and hurricanes. Its storm surge map indicates that over 3/4 of the city could experience flooding in the event of a Category 4 Hurricane. Over half of the city would experience flooding in the event of a Category 3 Hurricane. Poquoson is more affected by flooding with over 3/4 of the city located in 100 year floodplain and Category 1 storm surge zone.

This project addresses these vulnerabilities by creating a trained, informed, and prepared citizenry through CERT & CART training, in addition to public outreach. The disaster response skills citizens learn in CERT lessens the Cities' vulnerability for loss of life in the aftermath of a catastrophic incident when professional first responders may not be immediately available. Citizens receiving CERT Terrorism training have a heightened sensitivity of behaviors potentially related to terrorism and knowledge to report suspicious activities. These classes reduce both Cities overall vulnerability.

Describe the vulnerability that this proposal addresses. Example: Transportation control systems are susceptible to cyber attack from external threat.

Consequence:

If this project is not funded, our outreach programs in disaster preparedness and safety will be significantly hindered. In FY 2019 Hampton and Poquoson's Citizen Corps reached a wide range of citizens through participating in public outreach events, CERT training, and CART training. In FY 2021 CERT members have served in various positions at our vaccination POD to include serving as scribes and assisting with transportation of clients in the vaccination clinic. If we do not receive grant funding this year we would be unable to offer most of these trainings due to equipment not being replenished, inability to pay trainers to teach courses, and inability produce needed handouts for outreach.

Describe the consequences of not funding the project. Example: The region conducted a cyber risk assessment and determined that an attack on one or more transportation control systems would cost the region \$800 million in damage and the economy. In addition, there would be significant dread from public not accustomed to this type of event.

Benefit:

This project will benefit the jurisdictions by continuing to provide training and outreach in Hampton and Poquoson that is open to the rest of the region and state. Continuing to support these programs Emergency Management will be able to conduct outreach in areas that have a high rate of crime and gang activity through Hamptons Safe and Clean program. The Poquoson CERT program is active in the community providing preparedness education and service at community events. This project also engages city staff and non-profit organization staff that might not work together other than on a disaster in these courses so the CERT and CART volunteers can meet them before hand and create a relationship that will serve all parties well during a disaster.

Vetted Regionalism:

The City Managers for Hampton and Poquoson are in full support of this application and have provided support letters. Hampton Roads All Hazards Advisory Committee (HRAHAC) has also provided a letter of support. The objective of the Hampton Roads AHAC is to promote the inter-jurisdictional and inter-agency coordination of emergency management issues and to foster emergency preparedness in the Hampton Roads area. HRAHAC members include many groups – local governments, health departments, private companies, military branches and more - all with the common thread of effective emergency preparedness capability.

Scope:

This grant is for Hampton and Poquoson and both are mentioned in the grant. This project will help support both jurisdictions Citizen Corps programs equally. Interaction will take place through joint CERT and CART classes and outreach. Our CERT members will also support other localities' CERT programs in the region and state as needed.

Resources Sharing:

All items submitted in this grant are supported by both communities. This is a 50/50 grant. Half of the class offerings and activities will be held in each city or in partnership with each other. Items that are purchased will be shared between the two jurisdictions. Hampton will be the fiduciary agent but all other aspects of this grant will be fully supported by both jurisdictions. All activities are open to all other jurisdictions for their residents to attend, but primary focus will be Hampton and Poquoson residents.

Capability Linkage:

This project supports Public Information and Warning, Community Resilience, and Whole Community by providing residents with preparedness information. It makes the whole community more prepared by conducting outreach and providing training to all residents. Citizens receiving CERT Terrorism training have a heightened sensitivity of behaviors potentially related to terrorism and knowledge to report suspicious activities.

This grant is geared towards the whole community as information is disseminated by residents' participation in Citizen Corps programs as well as our outreach events. The City of Hampton has various formats of outreach materials to reach the whole community including those with functional needs.

This grant also supports the Mass Care Services Core Capabilities by supporting our Community Animal Response Team program, which assists with sheltering animals in our disaster shelters. It also supports Health and Medical Services Core Capabilities by utilization of non-medical volunteers for staffing in vaccination PODS and mass care shelters.

It supports the preparedness goal of involving the whole community and making the whole community more prepared by conducting outreach and providing training to all residents.

Sustainment:

This project sustains CERT, CART, and outreach programs in Hampton and Poquoson.

Outcomes from previous projects:

Hampton has held multiple CERT basic courses, advanced trainings, a CERT leadership meeting, Pet First Aid & CPR class, and a CART leadership team meeting. Both CERT and CART participated in a functional/access needs shelter exercise in June 2017. The Office of Emergency Management conducted multiple outreach events. Hampton hosted a Teen CERT course on May 4, 2019. Members completed an Emergency Companion Pet Sheltering class in August, 2019.

Poquoson has held CERT Basic Courses, advanced trainings, exercises, and CERT leadership meetings as well as multiple outreach events. Basic training classes were not held in 2020 due to the COVID-19 pandemic.

The first Eastern Virginia CERT Rodeo was held in Hampton on March 3, 2018 and included seven jurisdictions. Approximately 150 CERT volunteers participated. The second Eastern Virginia CERT Rodeo was held in Hampton on March 3, 2019 with seven teams participating in the event. Unfortunately our last planned CERT Rodeo in March, 2020 was postponed due to the Coronavirus outbreak and the need to promote social distancing and extra sanitation at the host site.

Whole of Community:

Hampton and Poquoson's Citizen Corps programs are geared for the whole community. There is a place for everyone to help and in order to support this effort, this grant includes a request to hire sign language interpreters for CERT and CART classes, if needed. Hampton has a very vibrant deaf community and we would like to continue to include them in our Citizen Corps programs. In a 2016 Hampton CERT class, one of the students asked for and received a braille CERT book. Both cities have the goal of providing preparedness information to all that would like to participate. To this end, Hampton also has several large print and brail handouts that they bring to outreach events.

Both localities reach out to our private companies for support of resources and to help promote our training opportunities. We also both work closely with the area volunteer organizations, VOADS, as well as the Police & Fire Citizen Academies. In addition, Hampton utilizes Marketing, Inc., its public information office, to publicize information about preparedness and training opportunities. The Poquoson CERT program is active in community events such as holiday events and festivals. Poquoson CERT volunteers supported the mass vaccination center staffed jointly by the City of Hampton and the City of Poquoson.

Project Management:

This program will be managed by Hampton's Emergency Management (OEM) Deputy Coordinator (DC) who is the program manager for OEM volunteers. There are leadership teams for CERT in Hampton & Poquoson & they provide input on the projects & timeline for each of the projects & then submit them to the DC. If there is any discrepancy with a timeline for a project, the group lead and the DC will meet to discuss any obstacles and identify a solution for the problem. All equipment is cross-referenced with the Authorized Equipment List before submission. Overall grants compliance is handled by the DC.

Interpreters can be provided for classes, if needed, throughout the year & therefore are not mentioned in each section.

Jan. 1- Mar. 31, 2023 - Conduct CERT exercise, 1 CERT basic, & 1 Advanced CERT.

Hampton has applied for & received funding for this project for the last 5 years. We have expended 2014 - 2019 funds completing those projects. We are currently working on expending our 2020 funds to support Hampton and Poquoson's CERT Programs and Hampton's CART program.

Performance Measurement Plan:

Hampton and Poquoson OEM's conduct yearly review of all of their outreach events to include all Citizen Corps training and exercises. This is then presented to their City Managers in a year end summary, if requested. OEM actively tracks all volunteers through sign-in sheets at all training and outreach events. All sign-in sheets are turned into OEMs for record-keeping. The events participation numbers are tabulated and entered into an Excel outreach tracking sheet.

Results can be quantified in how many people we reach through training and outreach. If there is a major disaster that allows us the opportunity to call on our Citizen Corps volunteers to assist with disaster related tasks, we can quantify their contribution to the City. We would quantify their contribution by using the prevailing rate for volunteer hours and comparing it to how much we would have been required to hire additional staff or pay overtime for employees to conduct tasks. All outreach programs are also compared to the Core Capabilities Public Information and Warning targets to ensure all applicable targets are addressed.


