**PUBLIC COMMENT**

Ms. Glass read the protocol for the public comment period.

Mayor Gray called on the individual who signed up to speak, Joan Weaver.

Ms. Joan Weaver greeted those on the dais and Ms. Glass and extended sympathy to Mayor Gray and the Gray family from the Weaver family. She also thanked Ms. Glass for ensuring that she (Ms. Weaver) had everything she needed in order to do her presentation. Ms. Weaver then made the following statement: I've always said thank you when I needed to, but there's still a need in the Greater Wythe area, and we want you all to not forget that, being that you have what you wanted, the Commerce Center, don't forget - our needs still run deep. It hurt me very deeply yesterday, when I was in my backyard, great God from Zion, a baby buck from our Fourth Street where that school sat that is still running, looking - raccoons. We have

all of those things. So, remember us too. We are there, our Council. The purpose is enhancing the community quality of life when your codes and compliances comes out, keep that in mind. We, Catalpa Avenue, have had concerns on the present, clear and imminent danger versus non-threatening, cosmetic and the process that you use. Is it selective or is it vindictive? We need to know. We want to know. We're not asking anybody to do anything illegal or immoral, but when you put that down, you do it and you do it fairly. It has gotten to the point where I have even stood to ask it to be escalated. I am not the one. Karen Joan Weaver is not intimidated by anything, especially quote legal. If you say Hampton is an all-American City, let's make sure it is. Some of my best and most fairest moments from due process came, not from the municipal government, but from the court system itself. So do right, and remember what you did when we were ravaged? Now, you gave us a promise of neighborhood improvements. You work with us. Don't be condescending. Don't try to isolate, vindicate, but remember why you came there and be inclusive and keep us and consider us all. Last, but not least, City of Hampton, 2025 Virginia School Engagement Project Award - it was won through our blood, sweat and tears. Thank you.
