The City Manager, Mary Bunting, shared that the information used to formulate the budget is in its very preliminary stages and outlined the structure of the day.

In addition to the City Attorney, Cheran Cordell Ivery, and the Clerk of Council, Katherine Glass, the following city staff were present: Lori Green, Robin McCormick, Dacia Walker, Jonathan McBride, Cashayla Rogers, Steven Lynch, Stephanie McElmore, Wayne Davis, Trish Melochick, Chuck Rigney, Terry O'Neill, Dave McCauley, Nicole Clark, Nancy Olivo, Karl Daughtrey, Jason Mitchell, Brian DeProfio, Jenn Green, Steve Bond, and Randy Bagoly. The City's Treasurer, Christine Snead, and the City's Commissioner of the Revenue, Ross Mugler, were also present.

The first topic was background information and an overview of the budget which was presented by Brian Deprofio, Assistant City Manager.

The next topic was an overview of property taxes and the grocery tax which was presented by Ross Mugler, Commissioner of the Revenue, and Karl Daughtrey, Finance Director, provided information on real estate tax stabilization.

The next topic was on key budget driver focused rankings with Nicole Clark, Human Resources Director, covering compensation.

Ms. Bunting explained how the polling devices worked and, at 11:43 a.m., Mayor Tuck took a ten minute recess asking that those in attendance grab their lunches to eat as the meeting continued. After the recess, the topic continued with Nancy Olivo, Organizational Performance Manager, covering staffing.

At 12:15 p.m., Mayor Tuck had to step out of the room and Vice Mayor Gray presided until the Mayor's return at 12:30 p.m.

An exercise then took place to rank the priority of projects. Providing background information on the projects were Brian DeProfio (Assistant City Manager), Dave McCauley (Director of Parks, Recreation and Leisure Services), Jason Mitchell (Public Works Director), Steve Bond (Assistant City Manager), and Terry P. O'Neill (Planning Director).

A great deal of discussion took place on the citizen satisfaction bonus and end-of-year departmental savings program. Mayor Tuck allowed Treasurer Chris Snead to share her experience on these topics.

Mayor Tuck took a recess break from 1:40 to 1:50 p.m.

Karl Daughtrey facilitated the ranking of tax relief options. Prior to the polling, there was discussion about Council starting their work session on March 9th earlier in the day to continue their budget work. How public outreach on the budget might occur was also discussed. A possible field trip to the construction sites of Fox Hill Neighborhood Center, the Aquaplex, and the Mary W. Jackson Neighborhood Center may have to be postponed to a later date.

The prioritization of the Tier one projects will take place at a later date.
