I recently purchased the property at 106 Bristol Court, and have several concerns about the possibility of a funeral home / crematorium being built directly in front of my home. Unfortunately I could not get off work to attend the public hearing, but wanted to voice my concerns.

I fear that building a funeral home and crematorium so close to this neighborhood will cause a decline in property values for all of the surrounding homes. Building this type of facility in the subject area will certainly hinder resale of all property. I would not have purchased this home if there was a crematorium directly in front of it.

One of the main reasons I did decide to purchase this home is the beautiful view of Liberty Baptist church. If this project goes forward, that view will no longer exist. Instead, I will be looking at the grim view of a crematorium.

Additionally, I am concerned about smell, increased traffic, the possibility of a thru street from Big Bethel to Bristol court. A crematorium certainly cannot produce a pleasant odor. This is a relatively quiet neighborhood, and the possibility of a thru street and increased traffic (both vehicle and foot traffic), will definitely alter that in a negative manner.

The possibility of the subject land being made commercial is upsetting as I was told that it was zoned for residential purposes when I purchased my home.

I hope that my concerns will be considered. I would appreciate your feedback.
