Study Status

- August 5th:FHWA issued a Notice of Availability
- August 5th September 19th: Public review/comment period
- September 7th- 8th: Location Public Hearings
- October: Brief the Commonwealth Transportation Board







Alternatives





Alternative A

- Includes improvements to I-64 between I-664 and I-564
- Would result in a consistent six-lane facility
- Improvements to HRBT would be largely confined to existing right of way

- Route 164







- Route 164 Connector








Alternative D

- Includes all components of Alternatives B and C
- Applies a more narrow footprint than Alternative C
- The different footprint allows for more information and options to be available to the study

Summary of SEIS Findings

Milestone Schedule

August 5, 2016: Draft SEIS published for public review

- Notice of Availability published in Federal Register coupled with local announcements
- 45-day public comment period

September 7 & 8, 2016: Location Public Hearings

October 2016: Commonwealth Transportation Board

- Board will be formally briefed on the study in October
- Anticipate formal action on the preferred alternative by the end of the calendar year

Spring/Summer 2017: Final SEIS published

Similar publication as Draft SEIS

Summer 2017: First Record of Decision (ROD)
