

1 **Ordinance to Amend and Reenact the City Code of the City of Hampton, Virginia by**  
2 **Amending Chapter 21, Motor Vehicles and Traffic, and Adding Article X Entitled,**  
3 **“Additional Fine for Exceeding the Maximum Speed on Designated Residential Streets”.**

4  
5 **BE IT ORDAINED** by the City Council of the City of Hampton, Virginia, the following:  
6

7 1) That any and all prior actions taken by City Council pertaining to §46.2-878.2 of the Code of  
8 Virginia, additional fine streets, and installation of signs with regard to additional fines on  
9 residential streets, including but not limited to City Council’s Resolution adopted on July 13, 2005,  
10 be rescinded and repealed; and

12 2) That Article X, Chapter 21 of the City Code of the City of Hampton, Virginia be adopted to read  
13 as follows:

14 **Chapter 21 – MOTOR VEHICLES AND TRAFFIC**

18 **ARTICLE X. - ADDITIONAL FINE FOR EXCEEDING THE MAXIMUM SPEED ON**  
19 **DESIGNATED RESIDENTIAL STREETS**

20  
21 **Sec. 21-222. - Purpose.**

22 *The purpose of this ordinance is to supplement the traffic calming programs of the City*  
23 *of Hampton, by adding additional penalties and options to augment available traffic*  
24 *calming methods.*

25  
26 **Sec. 21-223. - Definitions.**

27 *The following definitions shall apply in this article:*

28 *Additional fine street. A residential street, or portion thereof, which has been*  
29 *designated as such in this article, on which signs displaying the maximum speed limit*  
30 *and the penalty as provided in this article for violations are displayed.*

31  
32 *Dead end street. A street which connects with or crosses another street at only*  
33 *one (1) end.*

34

35 *Street. Means the entire width between the boundary lines of every way or place*  
36 *open to the use of the public for purposes of vehicular travel in the city, including streets*  
37 *and alleys; and for law enforcement purposes, the entire width between the boundary*  
38 *lines of all private roads or private streets which have been specifically subject to city*  
39 *enforcement of city motor vehicle laws by an ordinance adopted by the city council.*

40

41 *Residential street. Any street in a residence district having a posted speed limit*  
42 *of not more than thirty-five (35) miles per hour.*

43

44 *Residence district. Means the territory contiguous to a street which is zoned as a*  
45 *residential district; or which is not zoned as a residential district, but where seventy-five*  
46 *(75) percent or more of the property contiguous to such street on either side thereof, for*  
47 *a distance of three hundred (300) feet or more along the street, is occupied by dwellings*  
48 *and land improved for dwelling purposes.*

49

50 *Staff report. Means any report compiled by city staff that includes the results of*  
51 *traffic calming studies and other traffic studies deemed necessary and material by the*  
52 *city manager, city staff, and/or city council to be conducted to identify a need to curtail*  
53 *excessive speeding on certain residential streets.*

54

55 ***Sec. 21-224. - Additional two hundred dollar fine for speed limit violation on***  
56 ***additional fine streets.***

57 *(a) Operation of any motor vehicle in excess of the posted speed limit on an*  
58 *additional fine street is unlawful and shall constitute a traffic infraction, and in*  
59 *addition to any other penalty provided by law, shall be punished by a fine of two*  
60 *hundred dollars (\$200.00).*

61

62 *(b) No portion of the fine provided for in this section shall be suspended unless the*  
63 *court so orders and the defendant successfully completes twenty (20) hours of*  
64 *community service.*

69 **Sec. 21-225. - Procedure for consideration of an additional fine street.**

70 (a) Upon receipt by the city of a petition signed by at least seventy-five (75) percent  
71 of the owners or tenants of all residential structures having lot frontage upon a  
72 residential street, or portion thereof, the city manager or city manager's designee  
73 shall cause a staff report to be produced for any residential streets identified in  
74 the petition and shall thereupon have such petition presented together with the  
75 staff report to city council for consideration.

76  
77 (b) In addition to the petition procedure provided in subsection (a) of this section, the  
78 city manager may cause to be conducted or the city council may, on its own  
79 initiative, direct the city manager or city manager's designee to cause to be  
80 conducted necessary and material traffic studies on an identified residential  
81 street, or portion thereof, and present a staff report to city council for  
82 consideration.

83

84 **Sec. 21-226. - Procedure for city council designation of additional fine streets.**

85 *If, based upon the staff report required by section 21-225, and upon such other*  
86 *information and considerations as city council shall deem necessary, city council finds*  
87 *that the residential street in question, or portion thereof, is experiencing documented*  
88 *speeding problems, and that the additional two hundred dollar (\$200.00) fine provided*  
89 *for herein should apply to the residential street, or portion thereof, in question, then city*  
90 *council may pass an ordinance amending section 21-227 designating said residential*  
91 *street as an additional fine street, whereupon the city manager shall take all actions*  
92 *necessary to erect signs in order to put such additional two hundred dollar (\$200.00)*  
93 *fine into effect.*

97 **Sec. 21-227. - Designated additional fine streets.**

98 *The following streets, or portions thereof, are designated as additional fine streets, and*  
99 *as such, violations of the posted speed limit shall be a traffic infraction and punished by*  
100 *a fine as provided in section 21-224:*

101 (a) *Northampton Drive from Todds Lane to Burton Street*

102 (b) *Gilbert Street from King Street to Eagle Point Road*

103 (c) *Michaels Woods Drive from Locksley Drive to Big Bethel Road*

104 (d) *Silver Isles Boulevard from Old Buckroe Road to Hall Road*

- 105 (e) *Farmington Boulevard from Todds Lane to Estate Drive*
- 106 (f) *Westview Drive from Saunders Road to Dead end*
- 107 (g) *Charlton Drive from Mercury Boulevard to Dead end*
- 108 (h) *Big Bethel Road from Mercury Boulevard to Todds Lane*
