The Hampton Commonwealth's Attorney's Office is requesting funds from VSDVVF for a full-time Commonwealth' Attorney. The attorney's main focus will be to prosecute felonies and misdemeanors involving violence against women, sexual abuse against minors and adults, as well as stalking and protective order violations. During the period of January 1, 2016 to December 23, 2016, 41 cases were prosecuted. From July 1, 2018 to June 30, 2018, it is estimated that this attorney will handle approximately 75 cases with support from this grant.
