MAYOR'S COMMENTS

Mayor Tuck shared that Hampton was selected by the Cities United team members to receive this year's City Award during their Annual Founders Award Ceremony which took place on October 22nd.

In 2019, they began the Annual Founder's Awards in honor of our founders and continued leadership, dedication, and commitment of the Cities United network. In addition, the City Award is presented in recognition of the support and leadership of the National League of Cities. It is given to an innovative partner city that models the work and leads the field in creating safe, healthy, and hopeful communities for Black young men and boys.

The Mayor then introduced Debi Henle, an Account Representative with the American Red Cross Blood Services, who presented the Mayor's Cup for the second consecutive year and provided a few statistics about how blood donations impact lives in our community.
