

Project Overview

- The proposed project will increase the capacity of the ditch by removing existing silt, widening the bottom, flattening the bank slopes, and removing trees that currently block the channel and impede access for maintenance.
- A permanent grass access drive will be created on the east side of the ditch to provide for construction access and future maintenance.
- Permanent drainage easements needed from 24 parcels.


Project Area





- Public Works would like to advertise by November 15, 2016.
- The goal is to have construction start in January 2017 with completion estimated by the end of May 2017.

Request for Condemnation Authority

- The majority of the the required acquisitions have been successfully negotiated and negotiations will continue with remaining property owners
- No property owners/tenants will be displaced as a result of this project
- Council is requested to approve condemnation authority on the remaining properties
- Actual condemnation will only occur IF negotiation efforts fail by the start of construction in late 2017
