City Manager Mary Bunting introduced Placemaking Planner Alison Eubank who gave a presentation.

Ms. Jamie Chapman greeted Council and staff and made the following comment: I am Jamie Chapman, I live at 204 Lighthouse Drive in the Fox Hill section of our City and I speak tonight in support of rezoning of 65 Hall Road to allow the City of Hampton to work closely with Fox Hill residents and community organizations to

establish a Neighborhood Center that will provide a safe and friendly environment for families to come together for fun, recreation, learning and community betterment.

Ms. Chapman continued stating the leaders of Hampton deserve high praise for championing the concept of Neighborhood Centers and working with an enthusiastic group of volunteers from Fox Hill. I am confident we will be able to create a good neighborhood center that will be greatly appreciated by the families in Fox Hill neighborhoods. We have a lot of planning yet to do, but our chances of success are guaranteed due to the wonderful help of some very talented and dedicated employees of the Community Development Department.

Ms. Chapman commented that what most important to the volunteers and staff who are creating the Fox Hill Neighborhood Center is to create a center that serves neighbors in the Fox Hill region of Hampton and helps to build a sense of community and good will. Thank you, again for your leadership and commitment to helping the citizens of Hampton try to improve our lives and our neighborhoods.

Mayor Tuck asked what the observation points represent.

Ms. Eubank replied that she could not answer with 100 percent accuracy but believed that refers to some of the measurements used in putting together the Wetlands Report.

#### **PUBLIC COMMENT**

Deputy Clerk Jennifer Green read the protocol for the public comment period.

Mayor Tuck announced that stating your address is not necessary as that

information is found on the form filled out prior to the meeting.

Mr. David Born stated I am here again to ask the City Council to vote on an amendment to an ordinance they made in 2011 restricting the building on private lanes and private roads. I have been trying for a while to get this done and would like the amendment to read to send the city inspectors, the fire inspectors, whoever inspects the road in question. If the roads will accept fire trucks and city trash trucks, issue permits. If won't, don't. I got a bunch of backing on this thing from a lot of tax paying citizens that live on these roads boarding private roads. Two of them in particular, down there on the first floor you have a banner of them with their picture - Billy Woods and Betty Woods. When I told Billy of this thing two weeks ago, if I told you the comment he told me I would be escorted out of here. This is a bad ordinance, it totally restricts all of us. If the roads will accept fire trucks and city trucks, issue the permits. I don't get it and don't understand it. I have been fighting this thing since January and I have hit nothing but road blocks, I don't get calls back. I get a little feedback, nobody calls me back. I asked for a meeting with the Council because three minutes is just not enough to discuss this thing. I do not understand why it cannot be voted on and resolved. Like I say, I have a lot of backing on this thing from a lot of people and have not talked to the first person who knows anything on this ordinance. Thank you.

Ms. Donna Little addressed Council and made the following comment. I am with Olde Hampton Community Association and we were very concerned about Olde Hampton Community Center which would be named Mary W. Jackson. She thanked City Manager Mary Bunting for bringing it out because they did feel like they were left out. The neighborhood is getting disgruntled and I have talked to Vice Mayor Gray and did get some updates and now it is being said in the open and think that will help with the neighborhood. Thank you for addressing this issue.

Mayor Tuck stated that Council has not forgotten about her neighborhood or the center.

Mayor Tuck stated to Mr. Born that each time he has received a call, he has called him back and tried his best to address Mr. Born's concerns. Mayor Tuck stated that today in closed session, Council was given a briefing on his situation and other similar situations and told Mr. Born they could talk further but it was not something that Council is recommending doing because of the number of issues and concerns involved.

David Born spoke on his issues regarding the subdivision

ordinance related to private roads.

Donna Little thanked City Manager Bunting for publicly announcing the City's commitment to continue working on the Old Hampton Community Center.
