We propose to the City of Hampton to expand our current business located at 2809 W. Mercury Blvd. to the next door unit 2807 W. Mercury Blvd.

Our current unit 2809 is 1,500 square feet and adding the proposed unit 2807 will add 1,000 square foot more to our existing location. We currently have five independent contractors working and adding the extra square footage will allow us to house two to three more independent contractors. All in house independent contractors file for their individual business licenses through the City Of Hampton.

We are open seven days a week; our hours of operation are: Monday through Saturday-12pm to 8pm, Sunday-12pm to 6pm. American Classic Tattoo averages about ten to twenty clients on a normal day. There are currently twelve parking spaces, one handicap parking space and have six extra parking spaces behind the building if needed. There are two main entrances from the road and one that leads to the rear of the building . The first is adjacent to W. Mercury Blvd., and both the second and rear entrances are adjacent to Twin Oaks Dr.

American Classic Tattoo provides professional tattoo and piercing services for our local citizens of Hampton and surrounding communities of Hampton Roads. We aim to have a successful company that is a leader in customer service and provides the best possible work for all our clients that walk through our doors.

This family owned business is a true "Mom and Pops" shop that has been operating for 9 years . We opened our first location on May 4, 2012 in the City Of Newport News. In our eighth year of successfully thriving in Newport News, we decided to expand and open a second location in Hampton on Feb. 8, 2020. Owner Erik Day operates the Hampton location while Lucia Day operates the Newport News location.

We thank all of the City Council members for taking the time to read our narrative statement to consider our proposal to expand our growing family business into the unit next door to our pre-existing location.

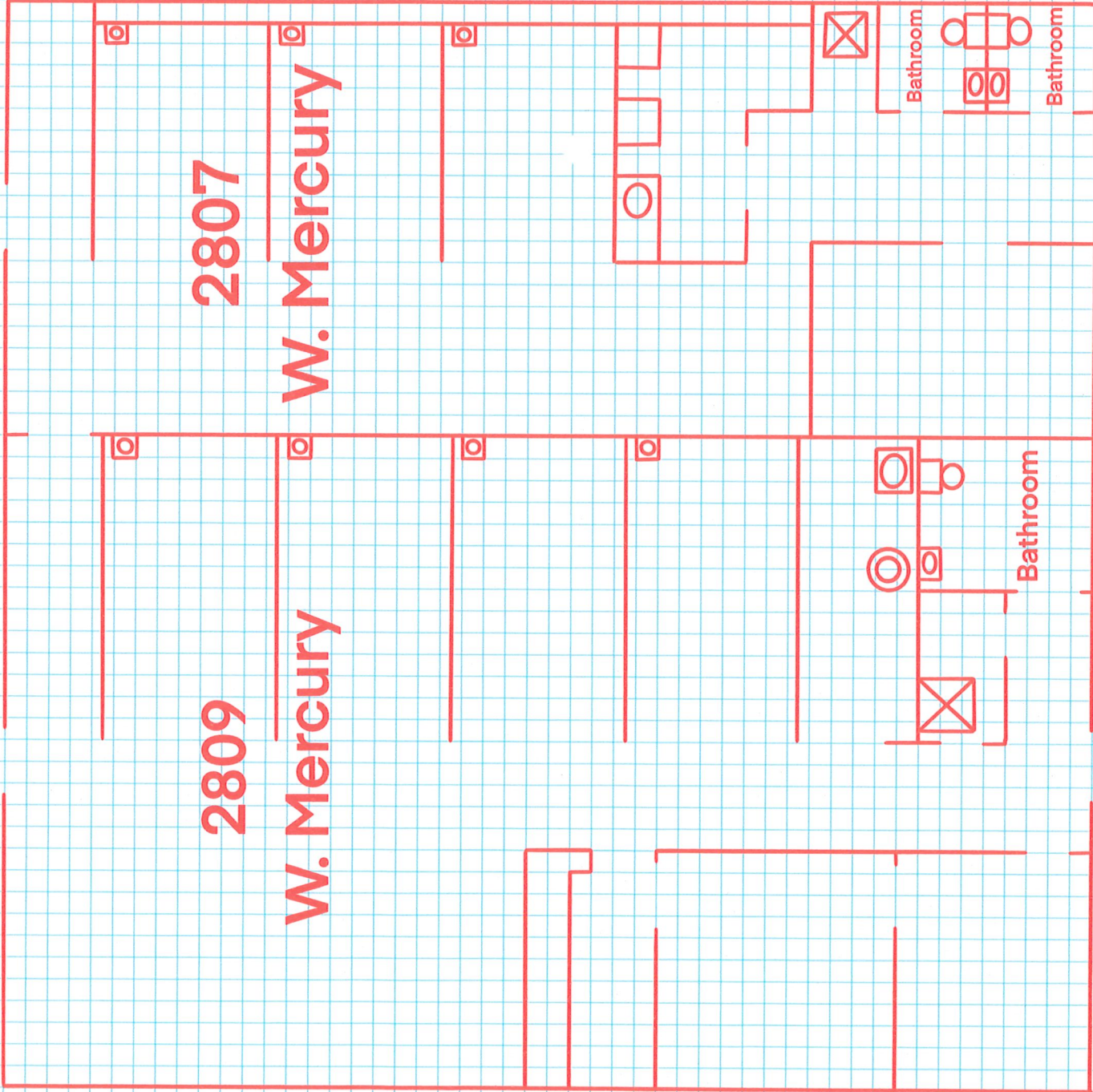

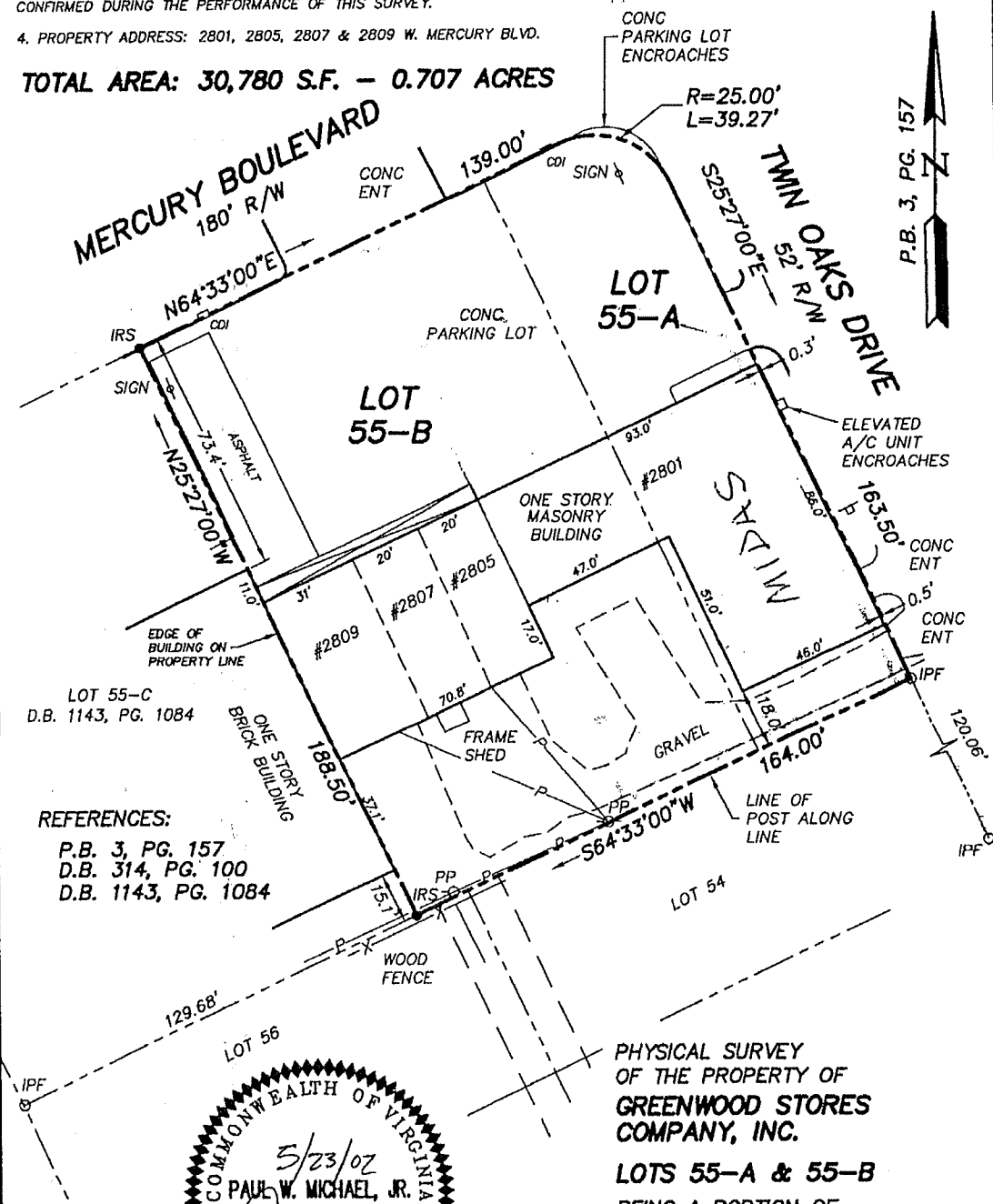

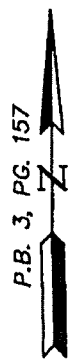
