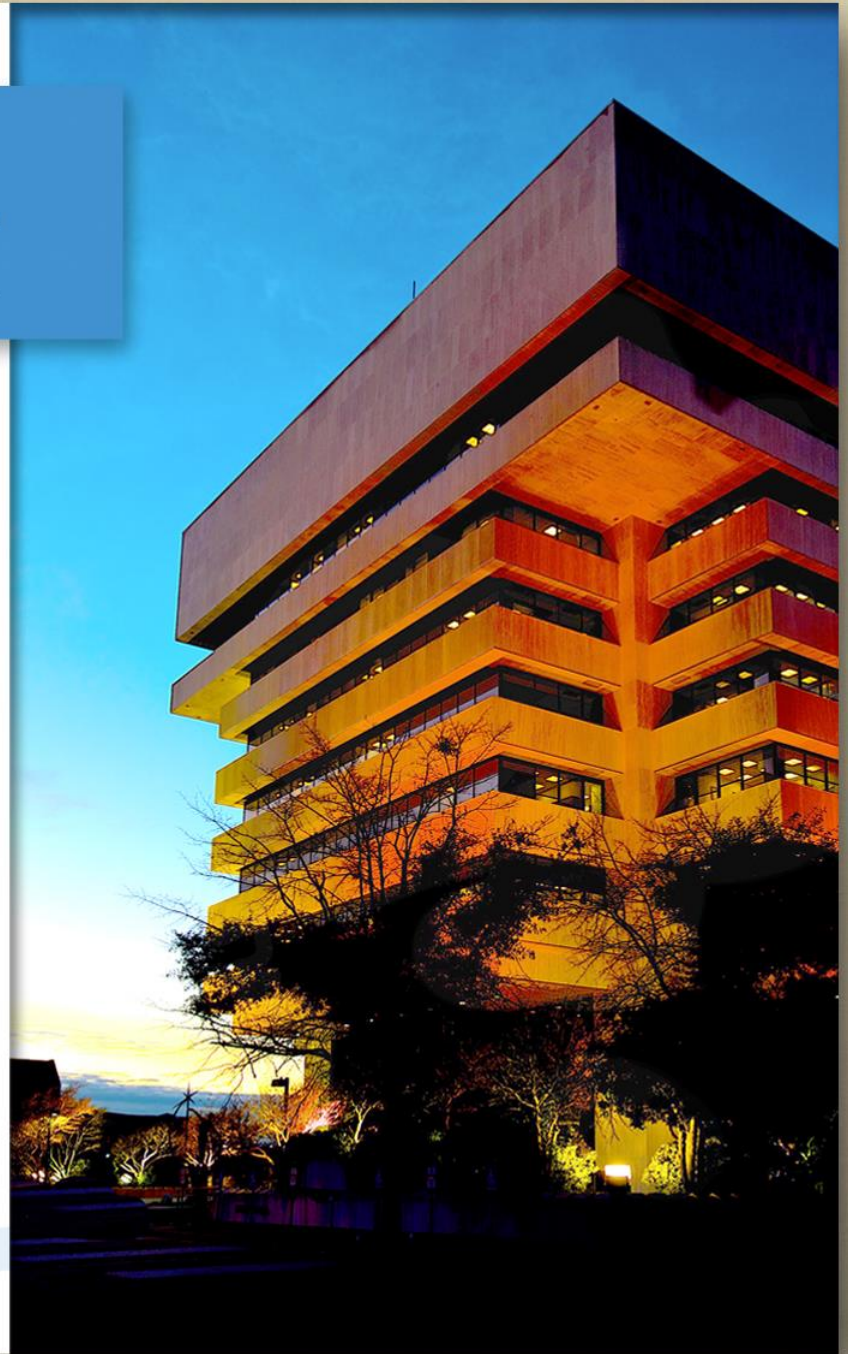

# Background

Awarded a special Community Development Block Grant (CDBG) allocation of **\$587,909** from the federal CARES Act to be used to:

- to provide relief from,
- to prevent the spread of, and
- to respond to the impacts of the COVID-19 pandemic.

# Background - CDBG-CV1

- City Council Approved an amendment to the 2019 Action Plan for CDBG-CV1 on May 13, 2020.
- HUD determined that the proposed Housing Rehabilitation activity did not qualify under new CARES Act guidelines.
- A new amendment must be approved and submitted that reflects the change.

# Background - CDBG-CV3

Awarded a special Community Development Block Grant (CDBG) allocation of **\$688,562** from the federal CARES Act from the federal CARES Act to be used

# Eligible Uses of CDBG-CV

1. *Buildings and Improvements:* Treatment/prevention related improvements to public facilities
  2. *Special Economic Development:* Grants, loans, and assistance to businesses
  3. *Provision of Public Services:* Relief activities unable to be funded by localities
  4. *Administrative & Planning Activities:* Data gathering, planning and studies
