Katherine K. Glass, Clerk of Council, read the call for the special meeting.

The purpose of this special joint meeting of the Hampton City Council, the Hampton School Board, the Hampton Economic Development Authority, the Hampton Planning Commission, and the Hampton Redevelopment and Housing Authority is to help the city reach its full potential as a vibrant and thriving place to live, work, play, and visit. This educational opportunity and conversation will offer guidance on the best path forward, which may include a new blueprint for growth; a framework for creating great streets, places and spaces; new zoning rules; a new public engagement approach; and a reimagined partnership between the City Council, staff, boards, commissions, and stakeholders.

Mayor Gray welcomed everyone and shared remarks as follow:

Before we start this special session, I want to thank everyone who is here with us today. The City Council is here, and City Manager Mary Bunting. Superintendent Raymond Haynes is here along with the school Board.

The Planning Commission is here. The Economic Development Authority is here, and also the Hampton Redevelopment and Housing Authority.

To the residents who have come here to join us today, this probably looks like a whole lot of people gathered together around these tables, and it is. Because that's what it takes to make a city of

137,000 people function cleanly and efficiently. We all have our separate and specific jobs to do, but in the big picture we have the same goal. Putting it simply, we are all committed and invested in moving the city forward.

What do we want to see for Hampton? We want safe neighborhoods, exceptional schools, a thriving business community, a strong economy, and a city where every resident, every family, feels like part of the Hampton community. Those are big goals, and achieving them doesn't come easily. It takes hard work every week of the year, from every one of the men and women we have here today. We have a great responsibility for the residents of Hampton and everyone at this table asked to be given that responsibility. We are proud to serve this city and its residents. So once again, thank you all for coming. We have important work to do, but we'll get it done because we will do it together.
