WHEREAS: the Hampton Planning Commission has before it this day a request

to amend the <u>Hampton Community Plan</u> (2006, as amended) to update the land use plan for the property commonly known as the Virginia School for the Deaf, Blind and Multi-Disabled in recognition of the Commonwealth's closure of the school and appropriate

reuse of the 76+ acres;

WHEREAS: the property consists of multiple lots for which two different land use

categories are recommended;

WHEREAS: 62+ acres contain LRSNs 1004270, 13002595, and 13002596, which

share the address 700 Shell Road;

WHEREAS: 14+ acres contain LRSNs 1004270, 13002597, 13002598, 13002599,

13002600, 13002602, 13002603, 13002604, 13002605, 13002601, 13002606, and 13002608, which is bound by Merrimac Avenue to the northeast, Gloucester Street to the southeast, and the City line

to the southwest;

WHEREAS: the 62+ acres is recommended for the business/industrial land use

designation;

WHEREAS: the large size of the site and proximity to interstate access make

this site ideal for light industrial use;

WHEREAS: the City of Hampton is largely built out and very limited vacant

space for light industrial activities exists;

WHEREAS: the 14+ acres is recommended for low density residential land use

designation;

WHEREAS: low density residential includes not only single family homes but

amenities, such as parks and open space, as part of its definition;

WHEREAS: the proposed change is only to the land use map, while all other

adopted goals, objectives, and policies within the <u>Hampton</u>

Community Plan (2006, as amended) remain unaffected;

WHEREAS: amending the <u>Hampton Community Plan</u> (2006, as amended)

does not change the zoning or other regulation of the use of the

property; and

WHEREAS: no members of the public spoke in regards to this proposal.

NOW, THEREFORE, on a motion by Commissioner Gaynette LaRue and seconded by Commissioner Gregory Williams,

BE IT RESOLVED that the Hampton Planning Commission recommends to City Council approval of Community Plan Amendment No. 16-00003.
