#### GOODYEAR SITE

#### LRSN 2002982 – S. King Street

thence, westerly along said property line approximately 156 feet to the easterly line of South King Street; thence, southerly along said line of South King Street approximately 139 feet to the northerly line of Bridge Street; thence, westerly across South King Street and along the Northerly line of Bridge Street approximately 310 feet to the northeasterly line of South Court Street; thence, southwesterly across South Court Street and along the northeasterly line of Collier Street approximately 85 feet to the extended westerly line of Bridge Street;
