




I fully endorse implementing and expanding the Barrett-Peake Educational and Cultural Center and I look forward to the role it will play in supporting stronger families and a healthier community.



The house located at 123 E. Pembroke Avenue, Hampton, Virginia, known as the Federation House, is an ideal project for renovation. If selected, this project would provide considerable benefit to Hampton while honoring the contributions of visionary women of color.
