

What our polling isn't – and what it is

- It isn't statistically valid
- It isn't random

- It records what people who choose to speak say
- It involves more people
- It is proactive and saves time.
 - If all 872 people came to a public hearing and spoke for their 3 minutes, we would be here 44 hours



What we were polling....

We only surveyed citizens on 2 questions:

- What is your preference for solid waste (in terms of fees)?
- What is your preference for stormwater (in terms of fees)?



What we were polling....


Citizens learned why solid waste fees needed to be increased:

- Increased cost to collect and dispose of refuse.
- Most household waste is burned and turned into steam energy. Energy prices have fallen, forcing a decrease in the price we can charge for our steam.
- Increased cost to collect and dispose of recyclable materials, caused by worldwide oversupply and contamination of many materials.
- Need to invest in technology for more efficient operations and addressing customer service needs.



What is your preference for solid waste?





- Maintain solid waste services at current level - \$7.25 weekly rate
- Reduce bulk/yard waste collections to every two weeks (keep recycling) -\$6.75 weekly rate
- Eliminate recycling (but keep bulk) -\$6.89 weekly rate
- Reduce bulk frequency and eliminate recycling - \$6.39 weekly rate



What we were polling....

Citizens learned that Hampton could accelerate floodreduction projects through an increase in the stormwater fee:


- \$1.00 per month would generate about \$1 million per year.
- The city would be able to obtain \$12-\$13 million in bonds in FY20, which would be used to jump-start larger projects. The bonds would be paid back over time with the proceeds from the fee increase.
- This could be a source of funding for projects currently being developed as part of Resilient Hampton and the Dutch Dialogues process.



What is your preference for stormwater?




Escalate floodreduction projects by raising the rate to \$8.83/month 52%



Keep the rate at \$7.83/month **48%**




Who participated: Gender





Who participated: Age






Who participated: Geography





