**RE: Sly Clyde Public Hearings** 

Good afternoon Ms. Toves,

Here are the following answers to your questions:

I received notice of 2 public hearings concerning rezoning a parcel of land & live entertainment for Sly Clyde Ciderworks. With my house being a matter of yards away I have concerns on this matter.

## What will the live entertainment cut off time be?

Currently, the applicant has a live entertainment 1 permit that was approved through the live entertainment 1 administrative process for Sly Clyde at 207 E Mellen Street. The live entertainment 1 permit has several attached conditions, including hours of live entertainment that cannot exceed 10PM Sunday to Thursday and 11:59PM Friday to Saturday. "Live entertainment 1 venues provide live entertainment within a building, with or without a dance floor or similar gathering area, and having a performance space of 75 square feet or less. Any other live entertainment venue is considered a live entertainment 2 venue." The applicant plans to continue providing indoor live entertainment but is also requesting outdoor live entertainment. The Live Entertainment 2 permit requires public hearings before Planning Commission and City Council. City Council votes as to whether or not to approve the this type of permit.

Since the applicant is applying for a Live Entertainment 2 permit, staff is recommending a condition to allow live entertainment during the following hours:

- o <u>Indoor</u> live entertainment hours from Sunday through Thursday 11AM-11PM Friday and Saturday 11AM-1AM.
- o <u>Outdoor</u> live entertainment hours from Monday through Thursday 4PM-8PM and Friday and Saturday 12PM-8PM.

Please note that the applicant plans to request Planning Commission and City Council allow the outdoor live entertainment hours extend to 10PM on certain days, and ultimately, Council will decide whether to go with staff's recommended condition above, or a different set of hours.

Where will these people coming to live shows park?

On-street parking will be available in addition to a few on-site spaces near the vacant florist building.

There's been an uptick in theft in the neighborhood lately, what will the city do to ensure our properties are secure with increased foot traffic?

The Hampton Police Division has police officers assigned to specific parts of the city, including the Phoebus neighborhood. The Phoebus police officers are familiar with the area and have a great relationship with the Partnership for a new Phoebus (PfNP), which is a neighborhood association that represents the residents and merchants of Phoebus. I recommend that to address any concerns you

may have, including building a relationship with the police officers assigned to Phoebus, you attend one of the PfNP meetings and discuss it with them. For how to get involved or speak with members of the PfNP, please contact Toni Williams, Executive Director for the PfNP at <a href="mailto:toni.williams@hampton.gov">toni.williams@hampton.gov</a>. Additionally, if the use permit is approved, there would be an attached condition that addresses security. Mandating security personnel monitor patron behavior upon leaving the business. They would be required to report any potential criminal activity to the Hampton Police Division.

Will the live entertainment be taking place closer to the building or the back of the parcel near the ballpark?

The live entertainment will be taking place in the backyard of Sly Clyde, closer to the production building and Cody's Lighting & Repair.

Is this set is stone yet? Or is the public hearing so we can aire our concerns. Do we actually even get a say?

Yes, you have a say in what is being proposed. The purpose of the public hearings are for stakeholders such as yourself, to be familiar with proposals and provide their comments.
