

# **Revenue Sharing Program**

- Program is defined in Section 33.2-357 of the Code of Virginia
- Projected statewide allocation for FY21 and FY22 is \$110M
- Funding for projects is 50% State and 50% Local in a twoyear Application Process
  - Request up to \$5M per locality annually (\$10M per two-year application cycle and project lifetime limit) projects designated by the locality for improvement, construction, or reconstruction and up to \$5 million for maintenance projects
- Resolution of the governing body required for a new project and funding applications

## **Revenue Sharing Projects**

- Identifying Candidate Revenue Sharing Projects:
  - Ongoing projects that need additional funding to complete (None this application cycle)
  - Construction and Maintenance projects that are in the City's adopted Capital Improvement Program (CIP) Plan that are to be funded with City funds (None this application cycle)
  - New projects that fit Revenue Sharing Program criteria that have been identified since approval of City's FY20 Capital Improvement Program (CIP)

## **Revenue Sharing Projects**

### FY21 and FY22 Candidate project:

#### 1) Grant Street Extension (0.25 miles)

- Total project costs: \$5.8M
  - State Revenue Sharing: \$2.9M
  - City Match: \$2.9M
- Purpose: To extend the Grant Circle, off Lincoln Street in Olde Hampton, to the east from McAllister Street to Armistead Avenue
- Includes a connection to North Stewart Street, the extension of Condor Street from Lincoln Street to the street extension, as well as three (3) additional side street connections from W. Queen Street and Lincoln Street to the street extension.

### **Transportation Alternatives Overview**

- This Program is authorized in the federal transportation bill: Fixing America's Surface Transportation (FAST) Act
- Can be used for construction of trail facilities, turnouts or overlooks, or historic preservation and rehabilitation of historic transportation facilities among others
- Funding for projects is 80% max Federal and 20% min. Local Match
  - 79% Federal and 21% Local Match is requested to increase the application score
- Competitive application process where projects are scored and ranked based on merit and readiness
- Application for program funding must be made by resolution of the governing body

#### **Previously Funded Projects:**

- o Pine Chapel Road Trail
  - Bass Pro Shoppes to Coliseum Drive
  - Construction is Complete
- Mellen Street Bike and Pedestrian Improvements
  - Mallory Street to Fort Monroe
  - Design is Underway; Started November '18

#### Mercury Boulevard Bike and Pedestrian Improvements Phase I

- Mallory Street to Willard Avenue
- Design is Underway; Started June '19
- Mercury Boulevard Bike and Pedestrian Improvements Phase II
  - Willard Avenue to Fort Monroe
  - Design is Underway; Started June '19
- Total Funds Received: \$3 Million Federal for 4 projects

### FY21 and FY22 Candidate Projects

1) Old Buckroe Road Pedestrian Improvements (1.4 miles)

- Pembroke Avenue to Fox Hill Road/Silver Isles Boulevard
- Total project costs: \$1.1M
- \$830K Federal TAP funds and \$221K City Match
- Purpose: Improvements to include completing sidewalks as well as other ADA compliant amenities that may be needed such as crosswalks, pedestrian crossing signals, and handicap ramps

## FY21 and FY22 Candidate Projects

2) North Mallory Street Reconstruction (1.0 miles)

- Mercury Boulevard to Shelton Road
- Total project costs: \$960K
- \$759K Federal TAP funds and \$202K City Match
- Purpose: Improvements to include reduction of lanes from 4 to 2 to allow for buffered bike lanes and includes pedestrian amenities such as ADA compliant crosswalks
- Included in the Bike Walk Hampton plan, adopted by City Council on December 14, 2016, and is also directly adjacent to the Birthplace of America Trail "alternative" route that was adopted by the Hampton Roads Transportation Planning Organization in July of 2017.

# **Primary Extension Repaving Program**

- This Program is authorized in the VA Code Section 33.2-358
- For pavement maintenance and ADA facility maintenance compliance
- Funding for projects is 100% State (Last Round)
- Competitive application process where projects are scored and ranked based on pavement condition, NHS, and volume
- 6 New Projects for \$1M Total:

  - 1) Revenue Sharing Program:
    - Grant Street Extension
  - 2) Transportation Alternatives Program:
    - Old Buckroe Road Pedestrian Improvements
    - N. Mallory Bike and Pedestrian Improvements
- VDOT FY20 Primary Extension funds for 6 projects
- Approved projects will be included in the next Virginia Department of Transportation (VDOT) Six Year Improvement Plan (SYIP) program, on July 1, 2020.
