### CEREMONIAL ITEMS: Spotlight on Hampton City Schools' Summer Business Institute

Mayor Tuck called upon Brian Marchese, Outreach and Creative Coordinator of Marketing INC, who presented information on the various Hampton City Schools' Summer Business Institutes. These institutes provided a great and unique opportunity that Hampton City Schools offers its students in an authentic, real-world business challenge where students, through teamwork, collaboration, research and on-site visits, design and develop a solution to address a specific business challenge. This opportunity allowed student teams to work directly with local businesses and industry partners over the summer. The 2021 Summer Business Institute was offered to rising juniors and seniors. From July 9 - August 5, 2021, students participated in the challenge for their 2021-2022 selected academy. Over four weeks, students worked with their assigned employer to address an authentic challenge faced by the business. Students created a product and then presented it

to the participating business partner. Each challenge-based learning experience is correlated to the academic and technical curriculum of its related career academy and demonstrates the integration of academic, technical and research skills in creative and critical thinking, problem-solving, collaboration and communication in career exploration.

Mr. Marchese recognized the businesses and industry partners that worked with Hampton students and they were presented with awards from members of City Council. Also in attendance were principals and executive staff members from the high schools.

Challenge 1: The Governor's Health Science Academy project, "Vaccination Nation". Yvonne Young, CEO, Professional Technical Learning Center, LLC, was the business partner that participated in this project.

Challenge 2: The Academy of Law and Public Safety project, "Crime Files". Sgt. Eric Rummel, Community Engagement Unit, Hampton Police Division, was the community partner that participated in this project.

Challenge 3: The Academy of Media Arts and Sciences project, "MAD about Business". Erica Spencer, Senior Business Development Manager, Small Business/Workforce Development, City of Hampton Economic Development Department, participated in this project.

For the next award, Mr. Marchese invited Kecoughtan High School Executive Principal, Dr. Violet Whiteman (not in attendance) and Extended Learning Coordinator Sharyna Smith to come forward.

Challenge 6: Academy of Entrepreneurship and Information Design project, "Collaborate to Make It". The partner for this program was Shannen Atkinson, Business Manager, Gather, Inc.

Challenge 7: On-Stage Performing Arts project, "Behind the Scenes". David Messic, Owner, Rainbow Puppets, partnered in this project.
