Ordinance to Adopt a Budget and Appropriate Monies for the Capital Budget (Capital Project) Fund of the City of Hampton for Fiscal Year 2023 beginning July 1, 2022 and ending June 30, 2023

PURPOSE/BACKGROUND:

This ordinance adopts a budget and appropriates monies for the Capital Budget (Capital Project) Fund of the City of Hampton as presented in the City Manager's Recommended Budget for Fiscal Year 2023.

Discussion:

This ordinance adopts a budget and appropriates monies for the Capital Budget (Capital Project) Fund for Fiscal Year 2023. The Capital Budget, as presented in the City Manager's Recommended Budget for Fiscal Year 2023, is based on the first year presented in the FY 2023-2027 (five-year) Capital Improvement Plan ("CIP"). The CIP was approved on April 27, 2022 after a public hearing. The budget includes both revenues and expenditures as prescribed on the attached budget schedule.

The public hearings necessary to adopt a budget and appropriate monies for the Capital Budget (Capital Projects) Fund were duly advertised in the Daily Press on April 17, 2022, April 20, 2022 and April 24, 2022.

Pursuant to Hampton City Code Sec. 2-50: "No ordinance or resolution appropriating money included in the annual budget shall be passed on the same day of its introduction, except that such an appropriation may be passed on the same day of its introduction by the concurrence of five (5) members of Council, pursuant to a motion made for that purpose." This ordinance is being introduced on May 4, 2022. Final approval will be requested at City Council's meeting on May 11, 2022.

Impact:

The total revenues and expenditures for the Capital Budget (Capital Projects) Fund are \$58,149,020.

Recommendation:

May 4, 2022: First Reading only. May 11, 2022: Final Approval.
