Ordinance to Adopt a Budget and Appropriate Monies for the General Fund of the City of Hampton (City and Schools) for Fiscal Year 2023 beginning July 1, 2022 and ending June 30, 2023

**PURPOSE/BACKGROUND:**

This ordinance adopts a budget and appropriates monies for the General Fund of the City of Hampton (City and Schools) as presented in the City Manager's Recommended Budget for Fiscal Year 2023.

**Discussion:**

This ordinance adopts a budget and appropriates monies for the General Fund of the City of Hampton (City and Schools) for Fiscal Year 2023. The budget includes revenues and expenditures as prescribed on the attached budget schedule.

The public hearings necessary to adopt a budget and appropriate monies for the General Fund were duly advertised in the Daily Press on April 17, 2022, April 20, 2022 and April 24, 2022. The budget was advertised in the Daily Press on April 17, 2022.

Pursuant to Hampton City Code §2-50: "No ordinance or resolution appropriating money included in the annual budget shall be passed on the same day of its introduction, except that such an appropriation may be passed on the same day of its introduction by the concurrence of five (5) members of council, pursuant to a motion made for that purpose." This ordinance is being introduced

on May 4, 2022. Final approval will be requested at City Council's meeting on May 11, 2022.

**Impact:**

The total revenues and expenditures for the General Fund (City and Schools) budget are \$581,958,724.

May 4, 2022: First Reading only.

May 11, 2022: Final Approval

**WHEREAS**, the City Council is required to annually consider the City Manager's Recommended Budget for the next fiscal year; and to adopt a budget and appropriate, by ordinance, funding consistent with that budget.

**BE IT ORDAINED** by the City Council of the City of Hampton, Virginia that the attached budget is adopted and appropriations are hereby made for the General Fund of the City of Hampton (City and Schools) for Fiscal Year 2023 beginning on July 1, 2022 and ending June 30, 2023.
